NOTIFICATION

Reference is drawn to Rule 170 of GFR 2017, wherein bid security is required in e- tender/Gem bidding to safeguard against a bidder's withdrawing or altering its bid during the bid validity period in the case of advertised or limited tender enquiry, Bid security (also known as Earnest Money) is to be obtained from the bidders.

The bidders have to furnish bid security along with their bids. The bid security may be accepted in the form of Account Payee Demand draft, fixed deposit Receipt, banker's Cheque or Bank Guarantee from any of the commercial Banks or payment online in an acceptable form, safeguarding the purchaser's interest in all respect. The Bids Security is normally to remain valid for a period of forty five days beyond the final bid validity period of e- bids.

In order to avoid duplication and efficiency in processing period in respect of refund of EMD/Bid security it is considered in Internal Purchase Committee dated 20/07/2020 to retain at the option of e-bidders on GEM/CPMP, a one time refundable amount of Rs Five Lakh for a period of five years and forty five days. The same shall be refunded or extended at the option of the bidders on expiry.
