OFFICE MEMORANDUM

Subject: Procurement through GeM Portal.

The undersigned is directed to say that Rule 149 of the GFR 2017 envisages for mandatory procurement of Goods and Services that are available on the GeM. This Ministry has also been emphasizing for the use of GeM portal for procurement by its Organizations/Institutes/CPSEs and to bring the more goods/service providers onboard on GeM portal.

2. Currently, GeM is facilitating the most of the Goods and Services on its portal and more and more Goods and Services are being added on regular basis to fulfil the requirements of procuring entities. However, it is noticed that the percentage of Goods/Services procured through GeM portal by procuring entities under the Ministry is still very low.

3. Therefore, all divisions of the Ministry are requested to instruct their procuring entities i.e. institutes/CPSEs/organizations to ensure that the Goods/Services may mandatorily be procured through GeM only. In case of any difficulty, procuring entities may communicate with their Divisional Heads or with GeM to smoothen out the procurement. ML

4. Further, all financial advisors of the procuring entities who are members of the Integrated Purchase Committee (IPC) may please ensure that the reasons for not procuring goods/services from GeM are recorded in the minutes of IPC in respective column alongwith efforts to ensure onboarding of such goods/services on GeM.
