NOTICE

With reference to the Circular No. NEIGR-DIR/01/2016-20/200 dated 28th December 2020, an interaction was called by the Director, NEIGRIHMS with all the Nursing Staff, Nursing Superintendent and all Deputy Nursing Superintendent in the Auditorium at 11:30 A.M. on 29th December 2020.

Director NEIGRIHMS welcomed those present including 88 Nursing Officers and Senior Nursing Officers. During the course of the interaction, it was informed that the issue of the resentment of the Nursing personnel was regarding the reservation in promotion given to 6 (Six) Senior Nursing Officer from Nursing Officers, which is affecting the seniority and duties.

Director apprised the Senior Nursing Officers and Nursing Officers that promotion for 6 (Six) Senior Nursing Officers belonging to the reserved category , was in accordance with provisions contained DOPT - Office Memorandum F. No. 36012/11/2016-Estt (Res –I) { T –ii} Dated 15^{th} June, 2018.

It was also informed that the Nursing personnel had already approached Court (CAT) on this matter and the matter is sub-judice. They may therefore await decision / direction, of the learned Court.

Director informed that a Committee comprising of Liaison Officer (ST/SC), Liaison (OBC), with members from the Administration is constituted for examining any genuine grievances pertaining to reservation in promotions for all employees of the Institute.

Director informed that Institute has received new sanction of sixty nine (69) posts of Senior Nursing Officer and the Departmental Promotion Committee (DPC) is scheduled on 7th & 8th January 2021.

Thereafter, the Director requested the Nursing Personnel to stay away from any form of agitation, especially during the COVID Pandemic period, in the overall interest of Patient Care Services.
