Advisory for all State Counselling authorities & State DMEs:

The Schedule of PG/ UG Counselling 2021 has been extended as per the directions of Hon'ble Courts in various matters pertaining to counselling from time to time.

In view of the above, MCC of DGHS is receiving representations from the State DMEs regarding revision of Schedule of State counselling since the schedule of All India UG/ PG Counselling being conducted by MCC of DGHS and that of state counselling are clashing.

In this regard, it is mentioned that as a principle, the state counselling for each round should be conducted once All India Counselling for respective round is completed by MCC of DGHS. Hence, it is advised that states may revise their schedule such that each round of state quota counselling is conducted after the All India Quota counselling conducted by MCC of DGHS as per the directions issued by Hon'ble Supreme Court of India in W.P(C) No. 76 of 2015 Ashish Ranjan & Ors.
