1. The last date of receipt of application has been extended up to 31.12.2018 up to 5.30 pm.
2. The crucial date for determining the age limit and qualification will be 31.12.2018.
3. The effective date up-to which the requisite experience must be completed is 30.06.2019.

4. **The recruitment of 1-OBC post of Associate Professor, Anaesthesiology, 1-UR post of Associate Professor, Blood Bank and 1-OBC post of Associate Professor, General Surgery advertised vide Advertisement No. NEIGR-E.II/19/2004/Pt. XX dated 24.05.2018** shall however depend on the outcome of O.A./43/351/2018 at the Hon'ble CAT, Guwahati Bench.
5. Candidates who had applied earlier pursuant to advertisement No. NEIGR-E.II/19/2004/Pt. XX dated 24.05.2018 need not apply afresh. However, incase they have acquired further qualifications and experiences in the interregnum, they may furnish further qualifications and experiences by filling further application or fresh application, within the last date of receipt of application i.e. 31.12.2018. They need not submit application fee.
6. The other terms and conditions of the advertisement No. NEIGR-E.II/19/2004/Pt. XX dated 24.05.2018 remains the same.

General Information:

1. Applicants already in employment in Government/Semi-Government/Corporate Bodies should route their applications through their employers or produce No Objection Certificate (NOC).
2. In case applicants willing to join the Institute on deputation he/she may also apply accordingly. The qualification & experience for the applicant willing to join the Institute on deputation will be: persons working in analogous post or post one level below shall be eligible for consideration provided they fulfil the requisite qualification & experience prescribed for direct recruit. The period of deputation shall ordinarily not exceed 3 (three) years at a time. The pay of the Faculty Members will be protected as per Govt. of India Rules. Upper age limit for candidate willing to come on deputation should not exceed 56 years as on 31.12.2018.
3. The candidates holding DNB qualifications would need to get their qualification verified by NBE as to whether it is as per the requirement of the Gazette notification No.MCI-12(2)/2010-Med. Misc dated 11.06.2012 and to submit such verification certificate along with application.
4. Applicants are required to ensure their eligibility in all respects before applying.
5. **The crucial date for determining the age limit and qualification will be the last date of receipt of application i.e. 31.12.2018.**
6. **The effective date up-to which the requisite experience must be completed is 30.06.2019**
7. A Post Graduate Qualification means the qualification recognised by the Medical Council of India as included in the "Minimum Qualification for Teachers in Medical Institutions Regulation, 1998" of the Medical Council of India.
8. Mere fulfilling the minimum educational qualification and experience doesn't bestow right to a candidate to be called for interview.
9. Period of probation for all faculty posts is for two years.
10. Accommodation will be provided to the faculty members appointed at the Institute, subject to availability of quarters.
11. AC second class train fare to and fro to the place of interview will be paid on production of tickets to the candidates who are called for interview.
12. Reservation for SC/ST/OBC (Non-creamy layers) will be as per Govt. of India norms.

13. Relaxation of upper age limit for SC/ST/OBC (Non-creamy layers)/Ex-serviceman/Handicapped/disabled candidates will also be allowed as per Govt. Rules, where reservations of posts are meant for these categories only.
14. Candidates belonging to OBC (Non-creamy layer) category are required to submit the latest OBC (Non-creamy layer) certificate issued by the competent authority in the current financial year 2018-2019.
15. Upper age limit is Relaxable by 5 years for Govt. servant in accordance with instruction of Govt. of India.
