**Pay Scale:** Assistant Professor: Pay Band 3 (₹15600-₹39100) with the minimum pay of ₹30000/- and Academic Grade Pay of ₹8000/-+NPA (Plus other allowances as admissible under the Govt. of India Rules)

**Age:** Not exceeding 50 years (as on **05.04.2017**)

**General Information:**

1. The appointment is purely on **ADHOC BASIS** initially for a period of six months, which may further be extendable subject to satisfactory performance or until further orders, whichever is earlier.
2. Reservation for the above post and age relaxation will be provided as per Govt. of India Norms. Age relaxation for Physically Handicapped candidates will be provided as per Govt. of India Norms.
3. If employed under the State or Central Government or PSU/Autonomous body, applicants are required to produce NOC from competent authority, failing which they will not be allowed to appear for interview under any circumstances.
4. The adhoc appointment can be terminated by either side by giving a notice of 1 (one) month, without assigning any reason.
5. During the adhoc appointment period private practice of any kind whatsoever shall not be allowed including any consultation and laboratory practice.
6. The appointment is subject to production of a certificate of fitness (in original) from the Medical Board of the Institute.
7. The period of adhoc appointment will not bestow on him/her any claim or right for regular appointment in this Institute and that the period of adhoc appointment rendered by him/her will not count for the purpose of seniority and for eligibility for promotion, confirmation etc.
8. The applicants are required to submit a bio-data alongwith attested copies of certificates/testimonials, other relevant documents viz age, educational qualifications, experience, integrity/character, caste certificate issued by competent authority, MCI registration certificate etc. with recent passport photograph on the date of interview. **The original Certificates should be produce at the time of the Interview.**
9. Candidates holding DNB qualification would need to get their qualification verified by NBE as to whether it is as per the requirement of the Gazette notification No.MCI-12(2)/2010-Med.Misc dated 11.06.2012 and produce such verification certificate at the time of interview.
10. Crucial date for determination of eligibility with regards to age, educational qualification and experience etc. will be the date; the candidates appear in the interview.

11. Candidate who does not fulfil any one of the above conditions will not be allowed to appear in the interview. They are to ensure that they fulfil the eligibility criteria before coming to appear the walk in interview on **05.04.2017**.
12. The appointee is not entitled to any TA for attending the interview and joining the post at the Institute.
13. Accommodation will be provided to the faculty members appointed at the Institute, subject to availability of quarters.
14. Incomplete application will not be considered.
15. The decision of the Institute's authority in respect of selection shall be final and no correspondence in this regard will be entertained.
16. Canvassing of any kind will be a disqualification.
17. Institute reserves the right to reject or accept any candidature without assigning any reason thereof.
