The applications must be dropped in the box provided in Examination Cell, Faculty Block, NEIGRIHMS with effect from the date of this Notification up to 27th September 2016 (5.00 PM).

(a) **Eligibility Criteria:**

Post Graduate in-service Senior Resident Doctors of NEIGRIHMS appointed on regular basis in the concerned departments are eligible to apply for the PDF.

(b) **Selection Criteria:** the selection of the candidates will be purely on merit of the Entrance Examination. Candidate will have to score 50% or above marks to be eligible for selection to the Courses.

(c) **Scheme of Entrance Examination:** The Entrance Examination will be written Multiple Choice Questions (MCQs) based with one single answer best response questions. There will be **no negative markings**. The Question Paper for each specialty will be based on **50% MCQs** from the General subject concerned (Anaesthesiology and Radiodiagnosis) and **50% MCQs** from basics of concerned specialty.

Total Marks: 60 (sixty) MCQs carrying 1 (one) mark each  
Duration of examination: 60 (sixty) minutes  
Date: 29<sup>th</sup> September 2016  
Time: 11-00 A.M. to 12-00 Noon (Reporting Time 10-00 AM)  
Venue: Examination Hall, NEIGRIHMS

\*Admit Cards to the candidates will be sent via email and candidates will have to bring the original downloaded printed copy of the admit card.

(d) **Other Conditions:**

The Period of PDF will be considered as Senior Resident Doctor; however mere completion of Post Doctoral Fellowship course will not construe completion of the Senior Residency Programme.

(e) **Duties and Responsibilities.**

In addition to the works under existing Rules & Regulations of Residency Scheme, SRDs admitted to PDF Programme will be required to perform such works as may be assigned to them and is necessary in the Interest of patient care, teaching, training, research and in emergency services as and when required to be supervised by the faculty not below the rank of Associate Professors.
