6. **Point -8:-** "The drum should be sand blasted to improve the ironing quality of the linens."
May be read as
"The drum should be sand blasted / nickel plated to improve the ironing quality of the linens."
7. **Point -10:-** "The Flat work ironing speed can be adjustable to maximum 10 m/Min."
May be read as
"The Flat work ironing speed can be adjustable between 1.5 to 10 m/Min."
8. **Point -14:-** "It should have a variable temperature control range upto 200 degree with minimum water evaporation rate 45 l/h."
May be read as
"It should have a variable temperature control range upto 180 degree with minimum water evaporation rate 45 l/h."
9. **Point -15:-** "The system should have supply with a compatible automatic linen folder with following specification.
 - a. Equipment should be single lane folder.
 - b. Equipment should have 3000 mm working width.
 - c. Equipment should capable folding 2 main folds and 3 cross folds.
 - d. Should have intelligent LCD touch screen type controller.
 - e. Folder should have self-diagnostic system along with safety parameters.
 - f. Folder speed should be synchronized with the speed of the ironer."*May be read as*

- a. Equipment should be single lane folder.
- b. Equipment should have 1800 mm working width.
- c. Equipment should capable folding bedsheets longitudinally.
- d. Should have intelligent LCD touch screen type controller.
- e. Folder should have self-diagnostic system along with safety parameters.
- f. Folder speed should be synchronized with the speed of the ironer"


