1. Bidders/Tenderers should submit Goods and Service Tax (GST) registration, PAN Number/Card, ST /SC Certificate, valid document regarding the existence and registration of the firm
 2. Tenderer/Agent who quotes for goods manufactured by other manufacturer shall furnish Manufacturer's Authorisation Form /Certificate.
 3. Bidder /Tenderer should submit Earnest Money Deposit (EMD) of Rs 30,000.00 (*Rupees Thirty thousand only*) in the form of Call deposit, Banker's Cheque, Fixed deposit or Demand draft, drawn in favour of Deputy Director (Admn.), NEIGRIHMS, Shillong or Bank Guarantee of any Scheduled Bank.

Within thirty (30) days from date of the issue of notification of award by the purchaser, the supplier shall furnish performance security to the purchaser at 5% of the contract value, valid up to sixty days after the date of completion of all contractual obligations by the supplier, including the warranty obligations.
 5. Bidder / Tenderer should submit financial turnover certificate during the last three years as ending 31st March, 2019 and last three installations in any Government Institute.
 6. If the offer is in Foreign Currency, Letter of Credit (LC) shall be operated on the respective principal with remittance against final installation and commissioning. In case of offer in Indian Rupees, the remittance shall be to the Indian subsidiary.
 7. No work will be allotted to Non-tribal bidder, contractors, Suppliers, stockists, bonded warehouse, private carriage contractors, cooperative societies etc except under a valid trading license issued by the Khasi Hills Autonomous District Council, Shillong.
