- 1. Please note that no counter proposal is acceptable to us and conditional offers are liable to be rejected.
- 2. Vendors /Contractors are required to submit copies of GST /Tax deduction / RVSF registration certificate, PAN Card, EPIC card and all other document relating to registration of the firm.
- 3. Bidders have to submit Earnest Money Deposit (EMD) of Rs 15000.00 (Rupees Fifteen thousand only), in the form of Call Deposit/ Bank draft/ Deposit valid for a period of forty five (45) days beyond the validity period of the tender, in favour of Deputy Director (Admn.), NEIGRIHMS, Shillong -793018.
- 4. The buyer will have to deposit the full payment of the sale value in the form of Call deposit /Bank draft/Cheque /Online transfer /deposit in favour of Deputy Director (Admn.), NEIGRIHMS, Shillong, within 7 (seven) days of acceptance of the offered rate.
- 5. Subject to realization of reserve price where the same has been fixed by NEIGRIHMS, Shillong, Vehicles shall be sold to the bidder quoting the highest price.
- 6. The Vehicle will be sold on 'as is' and 'where is' basis. The vehicles will be sold on the assumption that the bidder (s) have inspected the vehicles and know that they are buying. Interested bidder can inspect the Vehicles at the Institute's premises on all working days.
- 7. The Vehicle shall be taken from the site where they are parked with all faults and errors in description, if any, and no warrantee or guarantee shall be implied. NEIGRIHMS will issue sale release order signed by the competent authority /authorized officer to the buyer on production of full payment receipt.
- 8. Delivery of the Vehicles will be made only during working hours on all working days. The purchaser (s) will make own arrangements for transportation of the Vehicle (s) and he will not be entitled to claim any facilities from NEIGRIHMS.
- 9. Rate quoted should be inclusive of all taxes, transportation or any other unforeseen charges.
- 10. The bidder has to quote the price for the entire lot of Vehicles which shall be higher than or equal to the Gross Reserved Price.
- 11. The successful bidder will have to take delivery of the vehicles within seven days of issuance of formal order to lift the said vehicles, failing which the undersigned shall forfeit his EMD without any notice and forfeit the bidder's right over the vehicles and process will be initiated for handing over the vehicles to the second highest bidder at H-1 rate or cancellation of the bid process.

- 12. The undersigned will not be responsible for the safety of the vehicles. The vehicles will be disposed off on "as is where basis is".
- 13. The firm /agency shall scrap the Vehicles as per Motor Vehicles (Registration and Functions of Vehicle Scrapping Facility Amendment) Rules, 2022 and as per MORTH guidelines
- 14. It will be the responsibility of the tenderer to obtain necessary import/ stock evacuation/export permits, interstate sale/ movement permits, etc. from the authorities concerned in case the Vehicles are to be moved to places outside the District/ State/ Country.
- 15. Vehicles be removed by the buyer within the period specified in the order, with all the defects, if any, and notwithstanding any error or misstatements of description, measurement, quantity, weight, enumeration or otherwise and without any objection on the part of the buyer and no claim shall lie against the Institute, for compensation nor shall any allowance be made on account of such faults, mis-statements or errors although the same may be of considerable nature. NEIGRIHMS reserves the right to withdraw from the sale /offer included prior to the acceptance of any offer for such stores /offer without assigning any reason.
- 16. The buyer will make his own arrangement for transport (including loading /unloading) and will not be entitled to claim any facility or assistance for transport from the Institute.
- 17. The agency has to abide by all statutory rules and regulation of the Government of India /State and will be responsible for complying of all payment of minimum wages and other social security benefits (ESI, PF, leave /holiday, etc) as per manpower law, in force from time to time for the manpower engaged by the agency and deployed in the hospital.
- 18. The agency will be responsible for such conduct of the persons engaged by him in the Institute, which will be conducive for maintaining the harmonious atmosphere in the hospital and will be responsible for any act commission & omission of such persons.
- 19. Tender is to be duly signed on all the pages as a token of having accepted all the terms and conditions (no thumb impression is to be affixed).
- 20. The tendered rates and the validity of bids shall be for a period of one year, extendable upto 6 months, or till the finalization of the next tender, whichever is later.
- 21. Settlement of Disputes If there is any dispute or differences, the same may be referred to Director, NEIGRIHMS. Director, NEIGRIHMS or his authorized representative shall be the final authority in all disputes and decision taken by the authority will be binding on all concerned. Thereafter, the jurisdiction in respect of settlement of disputes in Stores & Civil contracts shall be as per the Commercial Courts, Commercial Division and Commercial Appellate Division of High Courts (Amendment) Ordinance 2018, wherein the provision for pre –institution mediation, has been made mandatory in respective cases by the parties to the disputes. The mediation shall be under the authorities constituted under Legal Service Authority Act, 1987 and that both the parties agree that the Courts in Shillong shall have the exclusive jurisdiction over any future disputes between the parties.
