I am to refer to M/s HSCC (I) Ltd, Noida notification of award No: HSCC/111/SPG/CSSD/2006, dated-6/10/2006 pertaining to Package-II(CSSD) and notification of award No: HSCC/111/SPG/MO/2006, dated-31/03/2006 for package-VI (Mortuary), which are inclusive of 2 years defect liability period, thereafter 3 years Comprehensive Maintenance Contract and your communication dated: 07/10/2013.

Several communication of even reference dated-26/07/2010, 15/09/2010, 3/8/2012, 30/8/2012 and communication D.O.NEIGR/S&P/Boxfile/Product Complaint/2012-13 dated-20/11/2012, 20/6/2012, 16/11/2012, pertaining to malfunctioning of the Mortuary chamber (Package-VI) and high pressure autoclave in CSSD (Package-II), have been forwarded to M/s Yorco Sales Pvt Ltd, Delhi, without any positive response or concrete action for early repair of the system.

Further, it is observed that M/s Yorco Sales Pvt Ltd, Delhi has not provided satisfactory services during the warranty period of 2 years and have been insisting for release of payment during CMC period, without provision of essential services. It may be noted that as per condition of contract of tender, CMC payments are to be processed only after provision of services, during the period of contract.

In view of non-provision of essential services, the Institute shall not process any further requirement from M/s Yorco Sales Pvt Ltd, Delhi till the time; all the systems are made to function, as per norms. I would like to inform you that there was a mechanical/technical failure of fully automatic high pressure autoclave after the servicing was done by an Engineer from Yorco Pvt. Ltd. supplier of the mention autoclave on 27<sup>th</sup> Oct. 2012 at around 11.00AM as the Engineer was running a post servicing test of the autoclave with the load in it.

Therefore the machine was out of order and it was understood that it may take a couple of month to restore its full function as per the said engineer's assessment.

The present work load is very high to cope up with the non availability of the unrepaired machine. Till now the work is not started at all by the company. It is for your kind information and necessary action please.



This has reference to your above mentioned letter regarding repairs of H<sub>2</sub>O<sub>2</sub> autoclave. In the same context we have to mention the following. The warranty period of the sterilizer is over long back. It is the third year after expiry of the warranty period. Previously also we have given services even after warranty period, on your pretext that the equipment is under warranty. But even after two years, of expiry of the warranty period we have not received the payments of AMC/CAMC. HSCC says, that you will pay for the AMC and you have written that you have already released the payment of AMC/CAMC to HSCC, but to date, HSCC has not released the amount.
