C I R C U L A R

In pursuance to the Ministry Letter No. Z.28015/06/2024-SAS-3(8291223), Ministry of Health & Family Welfare, Directorate General of Health Services, New Delhi, it is for general information to all concerned departments of the Institute that it has been recently observed that violence has become common against Doctors and other Health Care Staff in Government Hospitals. A number of Health workers suffer physical violence during the course of their duty. Many are threatened or exposed to verbal aggression. Most of this violence is done by either patient or patient's attendants.

In view of the above, it is stated that in the event of any violence against any health care worker while on duty, the Head of Institution shall be responsible for filing an Institutional FIR within a maximum of 6 hours of the incident.

Further, as instructed by the Competent Authority for any search incident in the Hospital, the Medical Superintendent should do the needful immediately.

This is issued with the approval of the Competent Authority.
