It is requested that all Faculty, Officer and Staffs of the institute's including JR(PG)/ SR(DM) and SRDs/ JRDs who are liable to pay Income Tax to kindly co-operate with the time schedule as per the Standing Circular.

It is hereby informed to all concerned employees who are liable to pay Income Tax that, there are 2(Two) Tax Regime i.e (1). New Tax Regime and (2). Old Tax Regime for calculating of Income Tax.

Therefore, all concerned employees are hereby requested to intimate the undersigned regarding his/ her intended tax regime during the Financial Year 2025-2026 for computation and calculation of Income Tax .i.e. (1) Old regime or (2) New regime.

This option can be exercised only once in a financial year and can only be change at the time of filing Income Tax Return.

In case, no option is received from the concerned employee/s within 30 (thirty) days from the date of issue of this circular, it will be presumed that the employee has opted for the new tax regime and tax shall be deducted in accordance with the rates provided under section 115BAC.

All sections/departments are requested to re-circulate the Standing Circular mentioned above amongst their staff for information and necessary compliance. *Failing which the institute will not be held responsible for any lapse in future.* 

This circular shall continue to be applicable for the subsequent financial years also until further notice.
