OFFICE ORDER

Central Vigilance Commission (CVC) has introduced the concept of Integrity Pact (IP) in order to ensure transparency, equity and competitiveness in Public Procurement. The pact envisages an agreement between the prospective bidders /vendors and the Institute.

CVC has appointed the following Independent External Monitors (IEMs) for NEIGRIHMS, to monitor the implementation of Integrity Pact in the Institute and to review independently and objectively, whether and to what extent the parties comply with the obligation of the pact.

The role, entitlement tenure, etc of IEMs are as per the revised Standard Operating Procedure (SOP) issued by CVC.

In line with the revised Standard Operating Procedure (SOP) in force, NEIGRIHMS has stipulated that all tenders /RFPs including award of contracts for all Hospital Stores, Disposables, Goods, Services, Civil /Electrical Works and all other stores, with threshold limit of Rs 50 lakhs and above, will be covered under the purview of Integrity Pact. This effectively means that bidders /vendors entering into agreement of contract for supply of goods or rendering of services, with threshold limit of Rs 50 lakhs and above, will have to compulsorily sign the Integrity Pact.

NEIGRIHMS shall hold quarterly meetings with the IEMs where a summary of the contracts awarded in the previous quarter, which are covered under the IP, shall be shared with the IEMs. Such summary of contracts include details like tender number, mode of tendering, period allowed for publicity, number of bids received, number of bidders considered eligible and name and address of the successful bidder.

Adoption and implementation of Integrity Pact are as per the revised Standard Operating Procedure (SOP) issued by CVC, vide Circular No. 04/06/23; dated: 14.06.2023 and is also available on the commission website.
