**Circular**

This is for general information to all concerned employees that the Internal committee on Cadre Review of the Institute has conducted a meeting with the stake holders on the revised proposal of the cadre review on 09.12.2024, 11.02.2025, 01.05.2025, 02.05.2025, 19.06.2025 and 24.10.2025. In the meeting of the Internal committee on Cadre Review, some of the stake holders has requested for modification of the proposal and also for additional man power / posts in their cadres.

The committee instructed the stake holders to submit the proposal as per AIIMS, PGIMER and other similar Institutes and in regard to the requirement of additional man power / posts the stake holders were instructed to submit the proposal to the concerned section dealing with creation of posts.

The Institute has received the revised proposal from the stake holders for modification of their cadres like upgradation of pay scale, hierarchy of the cadre and also for change of the nomenclature.

There are some stake holders who have not agreed to the proposal of the Institute, instead requested for modification and increase of man power / posts. The committee instructed them to submit the proposal for further examination and no proposal has been submitted by the concerned cadres.

The revised and modified proposal is put up for information of all the stake holders (Annexure - I) and in regard to the additional man power / posts required by the concerned cadres the same is forwarded to the concerned section dealing with creation of posts.

However, in regard to the cadres who have not submitted any proposal or comments as per instructions of the cadre review committee in the meeting with the stake holders the proposal made by the Institute will remain.
