CIRCULAR

This is for general information of all Employees who are governed by National Pension System (NPS) regarding those subscribers who registered on or after July 1, 2014 are mandatory required to submit the FATCA (Foreign Account Tax Compliance Act self-certification through online mode for NPS partial withdrawal.

The online self-certification can be exercised by the PRAN holder through the following modes;

- Log-in to your NPS account (please visit www.cra-nsdl.com)
- Click on sub menu "FATCA Self-Certification" under the main menu "Transaction"
- Submit the required details under "FATCA/CRS Declaration Form"
- Click on "Submit"
- You are requested to read and tick "Declaration & Authorization by all customers"
- Click on "Confirm"
- Enter OTP received on your registered mobile number.
- After Authentication through OTP, Acknowledgment for the completion of FATCA Self-certification will be displayed.

You are requested to provide Online Self-certification even if you have submitted/sent the physical Self-Certification Form to CRA. In case of non-submission of FATCA Self-Certification, you will not be able to make voluntary contribution or carry out withdrawal in your NPS/PRAN account.
