#### **Note:**

Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/Department of the Central Government shall ordinarily not exceed five years. The maximum age limit for appointment on deputation (ISTC) shall not be exceeding 56 years as on the closing date of receipt of application.

#### **General Information:**

- 1. - 3. Applicants already in employment in Government/Semi-Government/Corporate Bodies should route their applications through their employers or produce No Objection Certificate (NOC).

- 4. Candidates should note that mere fulfilling of the minimum requisite qualification & experience bestows no right on them to be call for test/interview.
- 5. Applications are required to ensure their eligibility in all respect before applying.
