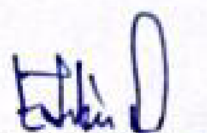

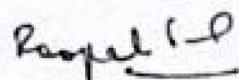

The revised Standard Operating Procedure (SOP) for adoption and implementation of Integrity Pact (IP) issued vide Circular No. 04/06/23 dated 14.06.2023 is available on Commission's website i.e. <https://cvc.gov.in>. The SOP may be made available to the IEMs for reference purpose. A copy of Commission's guidelines on "Illustrative check points for various stages of public procurement", available on Commission's website, under CTE's corner may also be provided to the IEMs at the time of their appointment, for guidance purpose.
8. It may be noted that as per Para 5.2 of revised SOP dated 14/06/23, it is necessary for the organization concerned to hold quarterly meetings with the IEMs, which may be complied with by the organization.
