Subject: North-Eastern Hill University - Recognition of MD(Radiodiagnosis) qualification for 2 seats in respect of students being trained at North Eastern Indira Gandhi Regional Institute of Health & Medical Sciences, Shillong.

Sir/ Madam,

I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 07/03/2018 considered the Compliance Verification Assessment Report (08/01/2018 along with the Council Assessor's Report (April, 2016, 10.03.2017) and compliance dated 22/05/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Radiodiagnosis) qualification for 2 seats at North Eastern Indira Gandhi Regional Institute of Health & Medical Sciences, Shillong granted by North-Eastern Hill University and decided as under:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (08/01/2018 along with the Council Assessor's Report (April, 2016, 10.03.2017) and compliance dated 22/05/2017 submitted by the college authorities and decided to recommend to the Central Government that MD(Radiodiagnosis) qualification for 2 seats granted by North-Eastern Hill University in respect of students being trained at North Eastern Indira Gandhi Regional Institute of Health & Medical Sciences, Shillong be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

"The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.

The above minutes of the Postgraduate Medical Education Committee have been approved by the Oversight Committee vide their letter dated 20/03/2018.
