Sir/ Madam,

I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 05/06/2017 considered the Council Assessor's Report (28.04.2017) on the standard of examination and other teaching facilities for Renewal of recognition of MD/MS(Pathology) qualification for 2 seats at North Eastern Indira Gandhi Regional Institute of Health & Medical Sciences, Shillong granted by North-Eastern Hill University and decided as under:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (28.04.2017) and decided to recommend to the Central Government that the recognition of MD/MS(Pathology) qualification for 2 seats granted by North-Eastern Hill University in respect of students being trained at North Eastern Indira Gandhi Regional Institute of Health & Medical Sciences, Shillong be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
