I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 26.06.2018 considered the Assessment Report (26th April, 2018) on the standard of examination and other teaching facilities available at North Eastern Indira Gandhi Regional Institute of Health & Medical Sciences, Shillong for purpose of Recognition of MD/MS(Pathology) qualification against increased intake from 2 to 3 seats granted by North-Eastern Hill University, Meghalaya. The Committee decided as under: -

"The Postgraduate Medical Education Committee considered the Assessment Report (26th April, 2018) and decided to recommend to the Central Government that MD/MS(Pathology) qualification against increased intake from 2 to 3 seats granted by North-Eastern Hill University, Meghalaya in respect of students being trained at North Eastern Indira Gandhi Regional Institute of Health & Medical Sciences, Shillong be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
