3 (three) posts reserved for Persons with Benchmark Disabilities in the non surgical departments as per Government of India policy:

**Criteria for Persons with Benchmark Disabilities:** One per cent each reserved for persons with benchmark disabilities under clauses (a), (b) and (c) and one per cent for persons with benchmark disabilities under clauses (d) and (e) namely:-

- (a) Blindness and low vision;
- (b) Deaf and hard of hearing;
- (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy;
- (d) Autism, intellectual disability, specific learning disability and mental illness;
- (e) Multiple disabilities from amongst persons under clauses (a) to (d) including deaf-blindness in the posts indentified for each disabilities.

The disability certificate should be issued by a duly constituted ad authorized Medical Board of the State or Central Government Hospital/Institutions and countersigned by Medical Superintendent /CMO/Head of Hospital/Institution.

The Medical Board issuing certificate shall conform to guidelines of Ministry of Social Welfare and Empowerment (Govt.of India)

Candidates from General and other Category will also be considered for adhoc appointment against vacant post of reserved category (<u>marked asterisk</u>\*), if reserved category candidates would not be available (<u>In respect of department of General Surgery & General Medicine, 2 posts each will be considered for adhoc appointment against OBC posts.</u>).

The numbers of vacant posts indicated above are **inclusive of backlog vacancies**.

As per guidelines EWS posts are not carried forward/or considered as backlog vacancy in case unfilled hence other category candidates may be allowed provisionally to apply for the post subject to the condition that they will be considered for the post as UR candidate only if EWS category seat is otherwise not filled up.

#### A. Essential Qualification for the post of Senior Resident Doctors:

- Post graduate degree (MD/MS/DNB) in respective fields/subject after obtaining a medical qualification included in Schedule I & II of 3<sup>rd</sup> Schedule to the Indian Medical Council Act of 1956 (Persons possessing qualification included in Part II of 3<sup>rd</sup> Schedule should also fulfill the conditions specified in Section 13(B) of the Act)
- ii. Satisfactory completion of the compulsory internship after MBBS.
- iii. The candidate must be registered with any State Medical Council/NMC.

<u>Scale of Pay</u>: Level 11 of Pay Matrix with entry pay of ₹.67700/- per month plus NPA and other allowances as admissible under the Central Govt. Rules in identical posts.

#### Age limit - 45 years

- ix. Result of screening test for Indian nationals with Foreign Medical Qualification issued by the National Board of Examinations.
- x. MD/MS/DNB passed certificate
- xi. Medical Registration Certificate for MBBS/MD/MS/DNB.
- xii. NOC from the present employer (if employed)
- xiii. Experience Certificate (if applicable)
- xiv. Residence Certificate issued by competent authority or Aadhar card or voter ID and Passport
- xv. Character Certificate

# The documents submitted by the candidates will be screened before the interview and only the eligible candidates who fulfill the eligibility criteria would be allowed to appear in the interview.

#### The date of interview will be published in the Institute's website.

The candidates should bring the original documents at the time of interview at the Institute. **<u>General Information</u>**:

- 1. Reservation for the above posts and age relaxation will be provided as per Govt. of India Norms. Age is relaxable upto 5 (five) years for SC/ST and 3(three) years for OBC (Non-creamy layers) candidates in respect of vacancies reserved for them. Age relaxation for physically handicapped candidates will be provided as per Govt. of India Norms.
- Reservation for Economically Weaker Sections (EWSs) shall be applicable as per Govt.of India policy Office Memorandum No.36039/1/2019-Estt (Res) dated 19<sup>th</sup> January, 2019 and 31<sup>st</sup> January, 2019.
  EWSs Candidates will attach certificate issued by the competent authority in the form prescribed as per Annexure-II.
- 3. Candidates belonging to OBC (NCL) category are required to produce the latest OBC (NCL) certificate issued by the Competent Authority during the current financial year i.e 01.04.2023 to 31.03.2024.

- 4. If employed under the State or Central Govt. or PSU/Autonomous body, applicants are required to produce NOC from competent authority, failing which they will not be allowed to appear for interview under any circumstances.
- 5. Candidate who have already worked in State or Central Govt. or PSU/Autonomous body and have resigned/left their jobs are required to produce the Relieving Order, failing which they will not be allowed to appear for interview under any circumstances.
- 6. Canvassing in any form will disqualify candidate.
- 7. Crucial date for determination of eligibility with regard to age, educational qualification and experience etc for third cut-off date will be the last date of submission of applications i.e 15.05.2025.
- 8. Candidates are to ensure that they fulfill the eligibility criteria at the time of submission of application, otherwise their candidature will not be considered.
- Candidates who have been sponsored by the Govt. of Meghalaya for MBBS/MD/MS programme and having bond obligations will be governed by the Mandatory Medical Public Services Policy (MMPSC) issued by the Govt.of Meghalaya, department of H&FW vide Notification No.Health.231/2024/6-A dated 04.03.2025 in lieu of NOC.
- 10. Candidates who have been sponsored by the respective state governments for pursuing MBBS course and are required to undergo compulsory rural posting, if any. Such candidates will have to submit the certificate of completion of rural posting. They will be allowed provisionally to appear for interview subject to compliance of mandatory requirement.
- 11. Appropriate accommodation as per availability will be provided.
- 12. No travelling allowance will be paid by this office for attending the interview.
- 13. Institute reserves the right to reject or accept any candidature without assigning any reason thereof.
- 14. The decision of the Institute as to eligibility or otherwise of a candidate will be final.
