The Institute has received an application from Shri Dilip Jaiswal, Husband of (Late) Sangita Bala Das, Ex-Senior Nursing Officer of the Institute who died in harness on 15th September 2018 at NEIGRIHMS, Shillong while in service for consideration of compassionate ground appointment.

The Chairman of the committee raised a query regarding details and number of cases where any other candidate or dependent of the Institute's deceased employee's shall be eligible for compassionate appointment after the present case. The Member Secretary appraised that there was only one case of Smt. Leonia Christy Nora Malngiang, Sister of (L) Bankerlang Malngiang, Ex-Storekeeper in the year 2020 & 2021 but as per office records, there is no eligible dependent for consideration.

The eligibility criteria for consideration of Shri Dilip Jaiswal application has been scrutinized in terms of Government Scheme for compassionate as per instruction/guidelines issued by Department of Personnel & Training, Government of India from time to time. To achieve the objective of the scheme of compassionate appointment and to ensure complete transparency, the committee has decided to adopt relative merit point assessment on a 100 point scale as per the Ministry's O.M dated 15.03.2021. Details of applicant is attached at **Annexure-I**.

As per the information provided by the applicant, the committee reviewed the financial conditions of the family including its assets and liabilities. Other relevant factors such as family pension, terminal benefits, left over service of the deceased, presence of an earning member, size of the family, ages of children and etc. Sheet of relative merit point allocated to the applicant on a 100 point scale is attached at **Annexure –II**.

There are 3 (three) vacancies available in Group 'C' posts under the direct recruitment quota for compassionate appointment as on 08.07.2022. On the basis of the relative merit point obtained by the applicant and meeting the required educational qualification for the post of Group C (Multi Tasking Staff), the Committee has recommended Shri. Dilip Jaiswal for appointment on compassionate ground to the post of Multi Tasking Staff (MTS) which is within the permissible of 5% ceiling of direct recruitment quota of the vacancy in Group C & Multi Tasking Staff (MTS) Posts in the current year. As Shri Dilip Jaiswal has crossed the age limit prescribed in the Recruitment Rules for the post of Multi Tasking Staff (MTS), a relaxation can be given in term of Para 6 B (a) of the DOPT's O.M dated 16.01.2013.


