

2. Shortlisted candidates (with requisite qualifications) will be intimated (through NEIGRIHMS website or email) the subsequent steps (offline interview) in the recruitment process.

Candidates must be able to produce all relevant documents related to their qualifications & experience in original and submit one set of photocopied and attested copies of the same and two passport size recent photograph, whenever required (prior to final selection). The Candidates not producing the Original Certificates will not be considered.
4. The candidates must be able to read and write and converse in English. Knowledge of the local language is desirable.

5. The project is for duration of 5 months. The post is purely temporary on contractual basis. The appointment may be renewed depending on performance of the candidate and extension of the project from the funding agency.
