General Terms and conditions:

1. The post is purely temporary on contractual basis. The appointment will be initially for a period of 3 months which may be renewable to a period of another 3 months, subject to satisfactory performance for the project duration. In any event the initial recruitment shall be for six months for the first phase of the project. For further engagement in the project fresh interview may be conducted or extension may be given depending on the suitable performance of the candidate.

- The duration of the said project will be for Five Years, subject to getting IEC approval from Institute Ethics Committee of NEIGRIHMS for the remaining part of the study (Study 2, Study 3 and Study 4)
- Candidates have to appear in the Walk-in Interview along with standard form application and CV
 in plain paper giving details of all educational qualifications and experiences.
- 4. Candidates must bring along all relevant documents related to their qualifications & experience in original and submit one set of photocopy along with one passport size photograph.
- 5. Only eligible candidates should come for the Walk-in Interview.
- 6. The candidates must be able to read and write local language (Khasi) as the project will be carried in and around Shillong city.
- 7. TA/DA will not be paid for attending the Interview.
- 8. All salaries & experiences will be as per ICMR guidelines.
- 9. No other allowance/facilities other than consolidated salary shall be admissible.
- 10. Age as on the date of interview should not be more than 35 years.
