No candidates will be permitted to attend the interview after the assigned time. No TA/DA will be provided for attending the interview.

Selection process: Verification of original documents along with experience certificates will be done for eligible candidates who fulfil the criteria for selection. Please note that only the candidates who fulfil the qualifications will be allowed to attend the interview.

Details of Terms and Conditions:

1. Candidate should possess required educational qualifications and minimum experience required for the post. It is the sole responsibility of the candidate to satisfy themselves about the required educational qualifications and minimum experience required for the post before applying for the same.
