**Eligibility**

1. Submission of filled up and signed declaration as contained in Annexure I **via e-mail at [deanofficeneigrihms@gmail.com](mailto:deanofficeneigrihms@gmail.com) on or before 15<sup>th</sup> October 2023 upto 4.00 PM.**
2. All the conditions stipulated in the PG Prospectus for admission into Post Graduate (MD/MS) 2023 at NEIGRIHMS are to be fulfilled with respect to the eligibility.
3. The freshly registered candidates are to visit the link for downloading the PG Prospectus for confirming to the eligibility criteria

The freshly registered candidates are to deposit Rs. 1500/- (fifteen hundred) only by NEFT/RTGS at **Bank of Baroda, Mawdiangdiang Branch, IFSC Code No- BARB0MAWDIA (0 is zero) Current Account Number 30270200000005, NEIGRIHMS MBBS ACCOUNT on or before 15<sup>th</sup> October 2023 upto 4.00 PM.**

### **Method of Counseling:**

- a) Only candidates who have not been allotted seat in 3<sup>rd</sup> Round Counselling for All India Category and counseling conducted by various State Government are eligible to participate in the NEIGRIHMS stray round counseling.
- b) The candidates who have already paid the fees of Rs- 1,500/- (fifteen hundred) only as per prospectus and candidates who have paid fees for appearing in the NEIGRIHMS 3<sup>rd</sup> counseling need not pay again. **However to appear in the stray round counseling the candidates are to submit declaration as provided at Annexure I via e-mail at [deanofficeneigrihms@gmail.com](mailto:deanofficeneigrihms@gmail.com) on or before 15<sup>th</sup> October 2023 upto 4.00 PM.**
- c) **The link to participate in the mop up round counseling will be only provided to candidates who have submitted the declaration to appear in the stray round counseling as stated above. Non submission of the declaration will render disqualification of the candidate.**
- d) The last date for joining/reporting to the course is **20<sup>th</sup> October 2023, upto 4.00 PM.** The candidate are to physically join/report before the stipulated date for verification/retention of original documents and completion of other admission related formalities.
- e) The allotment of seat is provisional subject to verification of original documents, payment of admission fees and completion of other admission related formalities on or before the stipulated date.
- f) Non Joining/reporting before the stipulated date will result in cancellation of the provisional allotment without further communications thereof. The Institute reserves the right to intimate the Medical Counseling Committee, DGHS, MOHFW, Govt. of India for further necessary action as deemed fit
- g) The provisionally selected candidates are to submit their acceptance of seat, declaration, payment of admission fees of Rs- 69000/- (sixty nine thousand) only by NEFT/RTGS at Bank of Baroda, Mawdiangdiang Branch, IFSC Code No-BARB0MAWDIA (0 is zero) Current Account Number 30270200000005, NEIGRIHMS MBBS ACCOUNT on or before **20<sup>th</sup> October 2023, upto 4.00 PM.**
- h) If any of the Original Certificates as mentioned in the prospectus is found defective at a later date, eligibility for admission will be forfeited. If the Certificates are found in any other language, except in Hindi/English, a copy of Hindi/English translation by the Gazetted Officer should be accompanied along with the Original certificate.
