# 1st COUNSELING FOR B.Sc. NURSING ADMISSION FOR SESSION 2024-25

This is for information of all eligible candidates, who had applied for admission into B.Sc. (Nursing) Course at NEIGRIHMS, Shillong, that Counseling for admission to B.Sc. (Nursing) Course for the academic session 2024-25 will be held on the 30<sup>th</sup> August, 2024 at 11:00 a.m. in College of Nursing, NEIGRIHMS, Shillong on the basis of merit in the National Eligibility-cum-Entrance Test [NEET (UG) - 2024] conducted by National Testing Agency.

## CUT OFF SCORE FOR THE COUNSELING: NEET SCORE (Re-revised) OF 391

ELIGIBILITY: Should have applied for B.Sc. (Nursing) Course at NEIGRIHMS, Shillong.

The candidates who have obtained the CUTOFF score of 391 marks and above in the NEET (UG) - 2024 conducted by National Testing Agency and fulfilling the eligibility criteria will be called for the Counseling.

The candidates who are called for Counseling have to report in person at the above venue and must produce the following Certificates in Original as well as Xerox copy of all documents at the time of Counseling. No individual call letter/ phone calls will be sent or made for attending the Counseling. If a candidate fails to report at the venue of Counseling on the 30<sup>th</sup> August 2024 before 11:00 a.m. and failure to produce any of the following documents (in original as well as xerox copy), the candidate will not be considered for admission and the seat will be offered to the next deserving candidate without any further communication thereof.

- 2. Pass Certificate of the qualifying examination (10+2 standard)
- 3. Mark sheet of qualifying examination (10+2 standard)
- 4. Age Proof Certificate showing the date of Birth (High School Certificate / Secondary School Certificate / Admit Card of 10<sup>th</sup> or 10+2 Exams issued by the Board / University showing the date of birth / Birth Certificate of the Applicant issued by the competent Government authority)
- 5. Character and Conduct Certificate from the Head of Institution / School last studied/ Gazetted Officer.
- 6. 3 (Three) recent (Passport size colour photographs)

### Method of Counseling

- a. During the Counseling, the candidates will be called in order of merit. After verification of Documents and ascertaining the eligibility criteria, the candidates will be serially allotted seats on the basis of merit till all the 50 (Fifty) seats are filled up. Candidates who failed to attend Counseling/Medical Examination on the notified date shall forfeit their claim for admission and placement in the waiting list.
- b. Calling for Counseling does not mean allotment of a seat to a candidate.
- c. The Counseling Committee reserves the right to fill or to keep any number of seats vacant for valid reasons.

**Note:** If any of the original certificates listed above is found defective, eligibility for admission will be forfeited. If the certificates are found in any other language, except in Hindi/English, a copy of Hindi/English translation by a Gazetted Officer should be accompanied along with the original certificate.

- d. The selected candidates on the day of the counseling are to submit:
  - (i) Challan for payment of admission fees of Rs.16,800/- (Rupees sixteen thousand eight hundred) only including security deposits.
  - (ii) Bank Deposit in slip for payment of SNA fee of Rs.3,000/- (Rupees Three thousand) only.
- e. Mess Fees of Rs 10,950 /- (Rupees Ten Thousand Nine Hundred Fifty) to be deposited by the students quarterly. The Mess Fess is to be deposited at the time of admission and subsequently at the beginning of each quarter during the academic session.

- f. Non acceptance/ Non reporting on or before the stipulated date will lead to cancellation of the seat and the seat will be offered to the next deserving candidate with no further communications thereof.
- g. If seats are not filled up during the 1<sup>st</sup> Counseling on 30<sup>th</sup> August 2024, the 2<sup>nd</sup> Counseling will be held at a later date to be notified by the Institute. However, those candidates who are called for the 1<sup>st</sup> Counseling but failed to appear will not be eligible for the 2<sup>nd</sup> Counseling.
- h. The decision of the Counseling Committee will be final and binding on all.
