PUBLIC NOTICE

Amendment of Recruitment Rules for Faculty posts in NEIGRIHMS, Shillong

- The Governing Council in its 15th meeting held on 17.01.2024 has approved the proposal of the Institute for enhancement of upper age limit for direct recruitment of faculty post of Professor & Additional Professor in NEIGRIHMS from 50 years to 58 years.
- 2. Further, as per Clause 3 (j) of the Preamble of Recruitment Rule for Faculty posts, it is stipulated that the Postgraduate qualification for faculty means a Post Graduate Qualification recognised by the MCI as included in the 'Minimum Qualification for Teachers in Medical Institution Regulations, 1998' of the MCI. The National Medical Commission vide Gazette Notification No.NMC/MCI-23(i) dated 14.02.2022 has notified the "Teachers Eligibility qualifications in Medical Institutions Regulations, 2022". While notifying the new regulations, the "Minimum Qualification for Teachers in Medical Institution Regulations, 1998" has been repealed.

In view of the new NMC Regulations, the Post Graduate Qualifications for teaching faculty under Clause 3 (j) of the Preamble will also be amended accordingly.

The amendment of Clause 3 (j) of the Preamble is enclosed at **Annexure-I** and amendment of Column 6 of the Schedule of the Recruitment Rules of Faculty posts for enhancement of upper age limit for direct recruitment of faculty posts of Professor & Additional Professor as approved by Governing Council is enclosed at **Annexure-II**.
