North Eastern Indira Gandhi Regional Institute of Health & Medical Sciences, Shillong an autonomous Medical Institution under the Ministry of Health & Family Welfare, Govt. of India declares Walk-in-interview for recruitment for the post of Junior Resident Doctors under Govt.of India Residency Scheme for 1(one) year tenure. **This being a rolling Advertisement, further vacancies along with the Eligibility Criteria, Selection Procedure, Application Procedure, Terms and Conditions etc as amended from time to time will be uploaded on our Institute website only and not be published in either Employment News or any News Papers.**

The 1st cut of date for submission of applications is 21 days from the date of publication of advertisement in Employment News.

Subsequent cut-off dates for submission of applications will be uploaded in the Institute website

Eligibility will be determined with respect to cut-off dates for respective rolling cycle.

Number of vacancies for each cycle with details shall be uploaded in the Institute's website only after the last cut off date of pervious cycle.

A notice for the subsequent cut of dates will be issued on NEIGRIHMS official website only.

NEIGRIHMS, Shillong reserves the right to continue more cycles. Once all positions are filled, no more applications will be considered.

2 (two) posts reserved for Persons with Benchmark Disabilities in the non surgical departments as per Government of India policy.

Criteria of Persons with Benchmark Disabilities: One percent each reserved for persons with benchmark disabilities under clauses (a), (b) and (c) and one percent for persons with benchmark disabilities under clauses (d) and (e) namely:-

- Blindness and low vision;
- Deaf and hard of hearing;

- c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy,
- d) Autism, intellectual disability, specific learning disability and mental illness;
- e) Multiple disabilities from amongst persons under clauses (a) to (d) including deaf-blindness in the posts indentified for each disabilities.

The disability certificate should be issued by a duly constituted ad authorized Medical Board of the State or Central Government Hospital/Institutions and countersigned by Medical Superintendent/CMO/Head of Hospital/Institution.

The Medical Board issuing certificate shall conform to guidelines of Ministry of Social Welfare and Empowerment (Govt. of India).

As per guidelines EWS posts are not carried forward/or Considered as backlog vacancy in case unfilled hence other category candidates may be allowed provisionally to apply for post subjected to condition that they will be considered for the post as an UR Candidate only if EWS category seat is otherwise not filled.

Educational qualification for the posts of Junior Resident Doctors:

- i. Medical qualification included in the Schedule – I & II of the 3rd Schedule of the Indian Medical Council Act 1956 (persons possessing qualifications included in the part – II of the 3rd schedule should also fulfill the conditions specified in section 13 (B) of the Act).
- ii. Satisfactory completion of the compulsory internship.
- iii. Candidate must be registered with the Central/State Medical Council.

Scale of Pay: Level 10 of Pay Matrix with entry pay of Rs.56,100/- plus NPA and other allowances as admissible under rules.

Age limit – 30 years

- xi. Result of screening test for Indian nationals with Foreign Medical Qualifications issued by the National Board of Examinations.

The documents submitted by the candidates will be screened before the interview and only the eligible candidates who fulfill the eligibility criteria would be allowed to appear in the Interview.

The date of Interview will be published in the Institute's website.

The Candidates should bring the original documents at the time of interview at the Institute.

General Information:

1. Reservation for the above posts and age relaxation will be provided as per Govt. of India Norms. Age is relaxable upto 5 (five) years for SC/ST and 3(three) years for OBC (Non-creamy layer) candidates in respect of vacancies reserved for them. Age relaxation for physically handicapped candidates will be provided as per Govt. of India Norms.
2. Reservation for Economically Weaker Sections (EWSs) shall be applicable as per Govt. of India policy Office Memorandum No. 36039/1/2019-(Estt (Res) dated 19th January, 2019 and 31st January, 2019.
3. EWSs Candidates will have to attach certificate issued by the competent authority in the form prescribed as per **Annexure-II**.
4. **Candidates belonging to OBC (NCL) category are required to produce the latest OBC (NCL) certificate issued by the Competent Authority during the current financial year i.e., 1.4.2024 to 31.3.2025.**
5. If employed under the State or Central Govt. or PSU/Autonomous body, applicants are required to produce NOC from competent authority, failing which they will not be allowed to appear for interview under any circumstances.
6. Canvassing in any form will disqualify candidate.
7. Crucial date for determination of eligibility with regard to age, educational qualification and experience etc. **will be the last date of submission of applications.**
8. Physically handicapped candidates are required to produce the physically handicapped certificate (with degree of disability) in original issued by the Competent Authority (i.e. Medical Board duly constituted by the Central Govt. or State Govt.) at the time of interview.
9. Candidates are to ensure that they fulfill all the eligibility criteria. Candidates who do not fulfill any one of the above conditions, will not be allowed to appear in the interview.
10. Candidates who have been sponsored by the Govt. of Meghalaya for MBBS programme are required to produce NOC from the Govt. of Meghalaya, prior to joining the post, if selected.
11. Candidates who have been sponsored by the respective state governments for pursuing MBBS course and are required to undergo compulsory rural posting, if any. Such candidates will have to submit the certificate of completion of rural posting.
12. Subject to availability, Resident Doctors will be provided accommodation in the RMO Hostel. In the event that no accommodation can be provided, HRA admissible as per rules will be paid.
13. Candidates who has completed the 1 (one) year tenure post as Junior Resident (house job) in State or Central Govt. or PSU/Autonomous bodies will not be allowed to appear in the interview under any circumstances.

14. Institute reserves the right to reject or accept any candidature without assigning any reason thereof.

15. The decision of the Institute as to eligibility or otherwise of a candidate will be final.

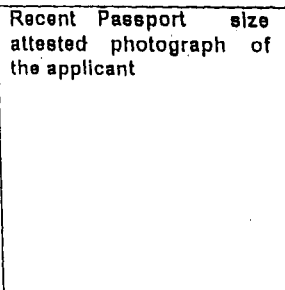
