Ministry of Health and Family Welfare invite applications for filling up 1 (one) post of Financial Adviser; in the Pay Level -13 (Rs.123100-215900) of the pay Matrix for North Eastern Indira Gandhi Regional Institute of Health & Medical Sciences (NEIGRIHMS), Shillong on deputation basis.

North Eastern Indira Gandhi Regional Institute of Health & Medical Sciences (NEIGRIHMS) is a premier medical Institution set up by the Government of India on lines of AIIMS, Delhi and PGIMER, Chandigarh. It is a super-specialty teaching Institute and provides advanced and specialized health care to people of north eastern India. The Institute is a 603 bedded hospital offering Out Patient and In Patient Services in various Super Specialty & Specialty Departments. The Institute is running various medical courses i.e. Post Doctoral (DM), Post Graduate (MD/MS), Under Graduate (MBBS) courses as well as M.Sc (Nursing) and B.Sc (Nursing) courses.

The following are the eligibility criteria for the post:

<u>Deputation</u>: - Officers from any of the Central/State Government organized Finance/Accounts Services or subordinate Finance /Accounts Services or officer in the Finance /Account Departments of Central Statutory / Autonomous Bodies /Public Sector Undertaking:

- 1. Holding analogous post on a regular basis in the parent cadre/department; or
- 2. with 5 years' service in the grade rendered after appointment on a regular basis in Level 12 of the Pay Matrix or equivalent in the parent cadre/department; or
- 3. with 10 years' service in the grade rendered after appointment on a regular basis in Level 11 of the Pay Matrix or equivalent in the parent cadre /department.

Note:

The period of deputation will be initially for one year, which is extendable not exceeding five years based on the review of the performance. The maximum age limit for appointment on deputation (ISTC) shall not be exceeding 56 years as on the closing date of receipt of application

Upper age limit: The maximum age limit for appointment by deputation shall not be exceeding 56 years.

The pay and other term and conditions of the official selected will be governed by the provisions laid down in the Government of India, DOPT's O.M. No.6/8/2009-Estt. (Pay.II) dated 17th June 2010 as amended from time to time.
