### **Project Notes**

A power supply will be required for charging the Independent Cage Lifter, Transfer Trolley, Hydraulic Stacking Trolley and Power Stacking Trolley.

Civil work will need to provide a wall mounted 16 amp commando socket, Single phase for charging

At some point, Tank embalming fluid will need to be replenished with fresh liquid. As such a drainage point is required for installation by Civils.

It is recommended a floor drain gulley; however, if this is not available, another form of drain is required. A 90° degree ball valve is provided at the bottom of each tank, which is suitable for a 1 inch/25mm hose pipe fitting to drain fluid.
