BETWEEN North Eastern Indira Gandhi Regional Institute of Health & Medical Sciences (NEIGRIHMS), having its perm anent campus located at Mawdiangdiang, Shillong -793018 (hereinafter referred to as "NEIGRIHMS" which terms or expression shall, unless excluded by or repugnant to the subject or context, mean and include its successor-in-office, administrators or permitted assignees) of the First Part; AND M/s (Name and Address of Individual/Firm/Company), through ert name and designation of the Officer/Representative/Authorized Signatory), having its office at (hereinafter referred to as "The Bidder /Contractor" which terms or expression sh all, unless excluded by or repugnant to the subject or context, mean and include its successor in-office, ad ministrators or permitted assignees) of the Second Part; WHEREAS NEIGRIHMS has floated the Tender, vid (hereinafter referred to as "Tender /Bid") and intends to award, under laid down organizational procedures, for (Name of the Work /Goods /Services), vide No: (GeM Bid number with date) hereinafter referred to as "The Contract". AND WHEREAS NEI GRIHMS values full compliance with all relevant laws of the land, rules, regulations, economic use of resou rces and of fairness /transparency in its relations with its Bidder(s) and/or Contractor(s). AND WHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this Integrity Agreement (herein ref erred to as "Integrity Pact" or "Pact"), the terms and conditions shall also be read as integral part and parc el of the Tender /Bid documents and Contract between the parties. NOW THEREFORE, in consideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnesses as un der; 1. Commitments of NEIGRIHMS:- 1.1. NEIGRIHMS undertakes that no official of NEIGRIHMS, connected directly or indirectly with the contract, will demand, take a promise for or accept, directly or through inter mediaries, any bribe, consideration, gift, reward, favour or any material or immaterial benefit or any other advantage from the BIDDER, either for themselves or for any person, organisation or third party related to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting or implemen tation process related to the contract. 1.2. NEIGRIHMS will, during the pre-contract stage, treat all BIDDER alike, and will provide to all BIDDER the same information and will not provide any such information to any particular BIDDER which could afford an advantage to that particular BIDDER in comparison to other BIDD ER /TENDERER. 1.3. All the officials of NEIGRIHMS will report to the appropriate Government office any att empted or completed breaches of the above commitments as well as any substantial suspicion of such a b reach. 2. In case any such preceding misconduct on the part of such official(s) is reported by the BIDDER t o NEIGRIHMS with full and verifiable facts and the same is prima facie found to be correct by NEIGRIHMS, n ecessary disciplinary proceedings, or any other action as deemed fit, including criminal proceedings may b e initiated by NEIGRIHMS and such a person shall be debarred from further dealings related to the contract process. In such a case while an enquiry is being conducted by NEIGRIHMS the proceedings under the cont ract would not be stalled. 3. Commitments of BIDDER:- 3. The BIDDER commits itself to take all measures necessary to prevent corrupt practices, unfair means and illegal activities during any stage of its bid or dur ing any pre-contract or post-contract stage in order to secure the contract or in furtherance to secure it an d in particular commit itself to the following: 3.1. The Bidder will not offer, directly or through intermediari es, any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, c ommission, fees, brokerage or inducement to any official of NEIGRIHMS, connected directly or indirectly wi th the bidding process, or to any person, organization or third party related to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the Contract. 3.2. The BIDDE R further undertakes that it has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, br okerage or inducement to any official of NEIGRIHMS or otherwise in procuring the Contract or forbearing to do or having done any act in relation to the obtaining or execution of the contract or any other contract wi th the Government for showing or forbearing to show favour or disfavour to any person in relation to the c ontract or any other contract with the Government. 3.3. BIDDER shall disclose the name and address of ag ents and representatives and Indian BIDDER shall disclose their foreign principals or associates. 3.4. BIDD ER shall disclose the payments to be made by them to agents/ brokers or any other intermediary, in conne ction with this bid/contract. 3.5. The BIDDER further confirms and declares to NEIGRIHMS that the BIDDER is the original manufacturer / integrator/ authorized government sponsored export entity of the stores and has not engaged any individual or firm or company whether Indian or foreign to intercede, facilitate or in a ny way to recommend to NEIGRIHMS or any of its functionaries, whether officially or unofficially to the awa rd of the contract to the BIDDER, nor has any amount been paid, promised or intended to be paid to any s uch individual, firm or company in respect of any such intercession, facilitation or recommendation. 3.6. T he BIDDER, either while presenting the bid or during pre-contract negotiations or before signing the contra ct, shall disclose any payments he has made, is committed to or intends to make to officials of NEIGRIHMS or their family members, agents, brokers or any other intermediaries in connection with the contract and t he details of services agreed upon for such payments. 3.7. The BIDDER will not collude with other parties i nterested in the contract to impair the transparency, fairness and progress of the bidding process, bid eval uation, contracting and implementation of the contract. 3.8. The BIDDER will not accept any advantage in exchange for any corrupt practice, unfair means and illegal activities. 3.9. The BIDDER commits to refrain from giving any complaint directly or through any other manner without supporting it with full and verifiable facts. 3.11. Th e BIDDER shall not instigate or cause to instigate any third person to commit any of the actions mentioned above. 3.12. If the BIDDER or any employee of the BIDDER or any person acting on behalf of the BIDDER, e ither directly or indirectly, is a relative of any of the officers of NEIGRIHMS, or alternatively, if any relative o f an officer of NEIGRIHMS has financial interest/stake in the BIDDER's firm, the same shall be disclosed by t he BIDDER at the time of filing of tender. The term 'relative' for this purpose would be as defined in Sectio n 6 of the Companies Act, 1956. 3.13. The BIDDER shall not lend to or borrow any money from or enter int o any monetary dealings or transactions, directly or indirectly, with any employee of NEIGRIHMS. 4. Previo us Transgression:- 4.1. The BIDDER declares that no previous transgression occurred in the last three year s immediately before signing of this Integrity Pact, with any other company in any country in respect of an y corrupt practices envisaged hereunder or with any Public Sector Enterprise in India or any Government D epartment in India that could justify BIDDER's exclusion from the tender process. 4.2. The BIDDER agrees t hat if it makes incorrect statement on this subject, BIDDER can be disqualified from the tender process or the contract, if already awarded, can be terminated for such reason. 5. Earnest Money (Security Deposit):-5.1 While submitting commercial bid, the BIDDER shall deposit an amount (as specified in the Bi d /Tender document) as Earnest Money/Security Deposit, with NEIGRIHMS, as specified in the Bid /Tender document. 5.2. (iv) To recover all sums alr eady paid by NEIGRIHMS, and in case of an Indian BIDDER with interest thereon at 2% higher than the pre vailing Prime Lending Rate of State Bank of India, while in case of a BIDDER from a country other than Indi a with interest thereon at 2% higher than the LIBOR. If any outstanding payment is due to the BIDDER fro m NEIGRIHMS in connection with any other contract for any other stores, such outstanding payment could also be utilised to recover the aforesaid sum and interest. (v) To encash the advance bank guarantee and performance bond/warranty bond, if furnished by the BIDDER, in order to recover the payments, already m ade by NEIGRIHMS, along with interest. (vi) To cancel all or any other Contracts with the BIDDER. The BID DER shall be liable to pay compensation for any loss or damage to NEIGRIHMS resulting from such cancell ation/rescission and NEIGRIHMS shall be entitled to deduct the amount so payable from the money(s) due to the BIDDER. (vii) To debar the BIDDER from participating in future bidding processes of the Government of India for a minimum period of five years, which may be further extended at the discretion of NEIGRIHMS . (viii) To recover all sums paid in violation of this Pact by BIDDER(s) to any middleman or agent or broker with a view to securing the contract. (ix) In cases where irrevocable Letters of Credit have been received in respect of any contract signed by NEIGRIHMS with the BIDDER, the same shall not be opened. (x) Forfeitur e of Performance Bond in case of a decision by NEIGRIHMS to forfeit the same without assigning any reaso n for imposing sanction for violation of this Pact. 6.2. NEIGRIHMS will be entitled to take all or any of the a ctions mentioned at para 6.1 (i) to (x) of this Pact also on the Commission by the BIDDER or any one emplo yed by it or acting on its behalf (whether with or without the knowledge of the BIDDER), of an offence as d efined in Chapter IX of the Indian Penal Code, 1860, or Prevention of Corruption Act, 1988, or any other sta

tute enacted for prevention of corruption. 6.3. The decision of NEIGRIHMS to the effect that a breach of the provisions of this Pact has been committed by the BIDDER shall be final and conclusive on the BIDDER. Ho wever, the BIDDER can approach the Independent Monitor(s) appointed for the purposes of this Pact. 7. Fal I Clause:- 7.1. The BIDDER undertakes that it has not supplied/is not supplying similar product/systems or s ubsystems at a price lower than that offered in the present bid in respect of any other Ministry / Departme nt of the Government of India or PSU and if it is found at any stage that similar product/systems or sub syst em was supplied by the BIDDER to any other Ministry/Department of the Government of India or a PSU at a lower price, then that very price, with due allowance for elapsed time, will be applicable to the present cas e and the difference in the cost would be refunded by the BIDDER to NEIGRIHMS, if the contract has alread y been concluded. 8. Independent Monitors: 8.1. There shall be Independent Monitors (hereinafter referred to as Monitors) appointed by NEIGRIHMS for this Pact in consultation with the Central Vigilance Commissio n. 8.2. The task of the Monitors shall be to review independently and objectively, whether and to what exte nt the parties comply with the obligations under this Pact. 8.3. The Monitors shall not be subject to instruct ions by the representatives of the parties and perform their functions neutrally and independently. 8.4. Bot h the parties accept that the Monitors have the right to access all the documents relating to the project/pr ocurement, including minutes of meetings. 8.5 As soon as the Monitor notices, or has reason to believe, a violation of this Pact, he will so inform the Authority designated by NEIGRIHMS. 8.6. The BIDDER(s) accept s that the Monitor has the right to access without restriction to all Project documentation of NEIGRIHMS inc luding that provided by the BIDDER. The BIDDER will also grant the Monitor, upon his request and demonst ration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monitor shall be under contractual obligation to treat the information an d documents of the BIDDER/Subcontractor(s) with confidentiality. 8.7. NEIGRIHMS will provide to the Monit or sufficient information about all meetings among the parties related to the Project provided such meeting s could have an impact on the contractual relations between the parties. The parties will offer to the Monit or the option to participate in such meetings. 8.8. The Monitor will submit a written report to the designate d Authority of NEIGRIHMS, within 8 to 10 weeks from the date of reference or intimation to him by NEIGRIH MS /BIDDER and, should the occasion arise, submit proposals for correcting problematic situations. 9. Facilitation of Investigation:- In case of any allegation of violation of any provisions of this Pact or payment of commission, NEIGRIHMS or its agencies shall be entitled to examine all the documents including the Bo oks of Accounts of the BIDDER and the BIDDER shall provide necessary information and documents in Engl ish and shall extend all possible help for the purpose of such examination. 10. Law and Place of Jurisdiction :- This Pact is subject to Indian Law. The place of performance and jurisdiction is the seat of NEIGRIHMS 11. Other Legal Actions:- The actions stipulated in this Integrity Pact are without prejudice to any other legal a ction that may follow in accordance with the provisions of the extant law in force relating to any civil or cri minal proceedings. 12. Validity: 12.1. The validity of this Integrity Pact shall be from the date of its signing and extend upto 5 years or the complete execution of the contract to the satisfaction of both NEIGRIHMS a nd the BIDDER/Seller, including warranty period, whichever is later. In case BIDDER is unsuccessful, this In tegrity Pact shall expire after six months from the date of the signing of the contract. 12.2. Should one or s everal provisions of this Pact turn out to be invalid, the remainder of this pact shall remain valid. In this ca se, the parties will strive to come to an agreement to their original intentions. The Parties hereby sign this Integrity Pact as part of the contract at _____ on_ . 1.
