Tender Description: Disposal /Spot Auction, on 'As is' 'Where is' basis, for disposal of old and unserviceable stores /items /waste –Empty Plastic Jar, Used Disinfected Latex Gloves, Old Newspaper, Shredded Plastic, of the Institute.

Offers are invited on behalf of Director, NEIGRIHMS, Shillong from reputed Firms /Agencies for collection & disposal of stores /items, addressed to the Deputy Director (Admn.), NEIGRIHMS, Mawdiangdiang, Shillong – 793018 with the words "Tender No & Date", with due date boldly superscribed on the top of the envelope.

Agencies /Firms should note that the following terms and conditions will apply specifically in addition to the Rules and regulations applicable to purchases in the Government of India.

- 1. Please note that no counter proposal is acceptable to us and conditional / late tenders are liable to be rejected.
- 2. Vendors /Contractors are required to submit copies of GST /Tax deduction /registration certificate (in case the vendor is liable to pay any tax), SC /ST certificate, PAN Card, EPIC card, etc.
- 3. The bidder /firm must not be blacklisted by any Department of the Government of India or of any State/or by any PSU/Autonomous Organisation of Government.
- 4. No picking, choosing, sorting, welding, cutting or breaking of goods or materials sold will be permitted. Welding cutting works if any can be arranged only with the prior permission.
- 5. Institute reserves the right to accept/reject and cancel any bid, amend the quantity under any lot or withdraw any lot at any stage before or after acceptance of bid/issue of acceptance letter/sale order/delivery order/deposit of the full sale value by the bidder, without assigning any reason thereof and the value of such material, if paid for, shall be refundable.
- 6. Bidders have to submit Earnest Money Deposit (EMD) of Rs 5000 (Rupees Five thousand only) in the form of Call Deposit/ Bank draft/ Deposit valid for a period of Forty Five (45) days beyond the validity period of the tender, in favour of EMD and Security Account, NEIGRIHMS, Shillong 793018.

- 7. The bidder /agency should make payment to the Institute, in the form of DD /Banker's Cheque, of the entire amount of cost of waste products/stores and the quantity allotted to them, within a period of 5 working days from the date of issue of release order /acceptance /order.
- 8. In the event of failure to complete the payment within the aforesaid period of 5 (five) days, NEIGRIHMS shall have the option to extend the period of 7(seven) days for making the payments provided, an interest of 18% per annum and storage charges at the rate of 10 paise per bag /kg or part of a bag /kg per day, subject to minimum of 40 paise per bag /kg or part thereof are paid by the party.
- 9. No work will be allotted to Non-tribal bidder, contractors, suppliers, stockist, bonded warehouse, private carriage contractors, cooperative societies, etc except under a valid trading license issued by the Khasi Hills Autonomous District Council, Shillong.
- 10. Bidders should be able to handle the waste products in accordance to the rules & norms of Municipal Solid Waste (Management & Handling) Rules 2000, Bio Medical Waste (Management & Handling) Rules 1998, Hazardous Waste (Management & Handling) Rules 1989 laid down by the Meghalaya Pollution Control Board.
- 11. Bidders have to collect the waste product from the premises of NEIGRIHMS, Mawdiangdiang, Shillong -793001 and disposal of the waste product will be the sole responsibility of the bidder /agency and the Institute will not be responsible in any situation arising thereof.
- 12. The bid of the highest acceptable responsive bidder is accepted.
- 13. In case the selected bidder /agency does not show interest in lifting the goods within the contracted period, the bid security will be forfeited.
- 14. Collection & Disposal of the waste product should be as per norms laid down by the Meghalaya Pollution Control Board /Registered Electrical Institute.
- 15. Stores will be sold subject to the condition of verification and inspection by the competent authority.
- 16. Each and every page of the terms and conditions of tender is duly signed of the firm /individual.
- 17. Rate per Quintal /Kg /Meter /Each, etc is to be clearly quoted against the lot /lots intended to be purchased.
- 18. In case, the successful bidder deposits the full amount within a stipulated period but fails to lift the articles in the scheduled time, this Office shall not take responsibility for safe custody of the articles
- 19. No damage shall be caused to the existing property or any other offices in the premises while removing the materials from the site. Any loss/ damage to the property of this Office or any other Offices in the premises or injury or personal accident suffered by any person due to negligence or action of the successful bidder or his authorized worker/supervisor will be borne by successful bidder and they will be indemnified
- 20. Goods/material will be removed under the supervision of a designated Officer(s)
- 21. All the charges i.e. loading, unloading and transportation to be incurred in course of lifting of items from the designated place shall be borne by the successful bidder.
- 22. The right for addition, deletion or alteration in figures / quantity rests with the undersigned. NEIGRIHMS reserves the right to withdraw any lot/lots from the sale at any point of time and also to accept or reject any or all offers without assigning any reasons thereof.
- 23. Conditional Tenders will not be accepted.
- 24. The Tenderers can see the lots at the concerned depots on all working days during office hours.
- 25. NEIGRIHMS will not be held responsible for delayed receipt of tender form by post and the tenderers may ensure that the forms are received by them in time and the duly filled forms submitted in time.
- 26. The consignment may be inspected by the intending tenderers on the authority of this tender form at the godown (s) on any working day wherefrom the delivery of the stocks shall be made.
- 27. It will be the responsibility of the tenderer to obtain necessary import/ stock evacuation/export permits, interstate sale/ movement permits etc. from the authorities concerned in case the stocks are to be moved to places outside the District/ State/ Country.
- 28. Stocks be removed by the buyer within the period specified in the delivery order, with all the defects, if any, and notwithstanding any error or misstatements of description, measurement, quantity, weight, enumeration or otherwise and without any objection on the part of the buyer and no claim shall lie against the Institute, for compensation nor shall any allowance be made on account of such faults, mis-statements or errors although the same may be of considerable nature. NEIGRIHMS reserves the right to withdraw from the sale any lot/ lots included in the tender prior to the acceptance of any offer for such lot/ lots without assigning any reason.

- 29. The buyer will make his own arrangement for transport (including loading /unloading) and will not be entitled to claim any facility or assistance for transport from the Institute.
- 30. The agency has to abide by all statutory rules and regulation of the Government of India /State and will be responsible for complying of all payment of minimum wages and other social security benefits (ESI, PF, leave /holiday, etc) as per manpower law, in force from time to time for the manpower engaged by the agency and deployed in the hospital.
- 31. The agency will be responsible for such conduct of the persons engaged by him in the hospital, which will be conducive for maintaining the harmonious atmosphere in the hospital and will be responsible for any act commission & omission of such persons.
- 32. Tender is to be duly signed on all the pages as a token of having accepted all the terms and conditions (no thumb impression is to be affixed).
- 33. Settlement of Disputes If there is any dispute or differences, the same may be referred to Director, NEIGRIHMS. Director, NEIGRIHMS or his authorized representative shall be the final authority in all disputes and decision taken by the authority will be binding on all concerned. Thereafter, the jurisdiction in respect of settlement of disputes in Stores & Civil contracts shall be as per the Commercial Courts, Commercial Division and Commercial Appellate Division of High Courts (Amendment) Ordinance 2018, wherein the provision for pre –institution mediation, has been made mandatory in respective cases by the parties to the disputes. The mediation shall be under the authorities constituted under Legal Service Authority Act, 1987 and that both the parties agree that the Courts in Shillong shall have the exclusive jurisdiction over any future disputes between the parties.
