The Bidder will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favourany ma terial or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of NEI GRIHMS, connected directly or indirectly with the bidding process, or to any person, organization or third party re lated to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the Contract.

The BIDDER further undertakes that it has not given, offered or promised to give, directly or indirectly anlyribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brok erage or inducement to any official of NEIGRIHMS or otherwise in procuring the Contractor forbearing to do or ha ving done any act in relation to the obtaining or execution of the contract or any other contract with the Govern ment for showing or forbearing to show favour or disfavour to any person in relation to the contract or any other contract with the Government.

BIDDER shall disclose the name and address of agents and representatives and Indian BIDDER shall disclose their foreign principals or associates.

BIDDER shall disclose the payments to be made by them to agents/ brokers or any other intermediary, inconnection with this bid/contract.

The BIDDER further confirms and declares to NEIGRIHMS that the BIDDER is the original manufacturer Integrato r/ authorized government sponsored export entity of the stores and has not engaged any individual or firm or company whether Indian or foreign to intercede, facilitate or in any way to recommend to NEIGRIHMS or any of its functionaries, whether officially or unofficially to the award of the contract to the BIDDER, nor has any amount be en paid, promised or intended to be paid to any such individual, firm or company in respect of any such intercess ion, facilitation or recommendation.

The BIDDER, either while presenting the bid or during pre-contract negotiations or before signing the contract, sh all disclose any payments he has made, is committed to or intends to make to officials of NEIGRIHMS or their family members, agents, brokers or any other intermediaries in connection with the contract and the details of service sagreed upon for such payments.

The BIDDER will not collude with other parties interested in the contract to impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.

The BIDDER will not accept any advantage in exchange for any corrupt practice, unfair means and illegalactivitie s.

The BIDDER shall not use improperly, for purposes of competition or personal gain, or pass on to others information provided by NEIGRIHMS as part of the business relationship, regarding plans, technical proposals and bus iness details, including information contained in any electronic data carrier. The BIDDER also undertakes to exerc ise due and adequate care lest any such information is divulged.

The BIDDER commits to refrain from giving any complaint directly or through any other manner without upporting it with full and verifiable facts.

The BIDDER shall not instigate or cause to instigate any third person to commit any of the actionsmentioned above.

If the BIDDER or any employee of the BIDDER or any person acting on behalf of the BIDDER, eithedirectly or indirectly, is a relative of any of the officers of NEIGRIHMS, or alternatively, if any relative of an officer of NEIGRIHMS has financial interest/stake in the BIDDER's firm, the same shall be disclosed by the BIDDER at the ti

me of filing of tender.

The term 'relative' for this purpose would be as defined in Section 6 of the Companies Act, 1956.

The BIDDER shall not lend to or borrow any money fromor enter into any monetary dealings ortransactions, directly or indirectly, with any employee of NEIGRIHMS.

#### 4. Previous Transgression:-

The BIDDER declares that no previous transgression occurred in the last three years immediately beforesigning of this Integrity Pact, with any other company in any country in respect of any corrupt practices envisaged hereu nder or with any Public Sector Enterprise in India or any GovernmentDepartment in India that could justify BIDDE R's exclusion from the tender process.

The BIDDER agrees that if it makes incorrect statement on this subject, BIDDER can be disqualified from the tend er process or the contract, if already awarded, can be terminated for such reason.

#### 5. Earnest Money (Security Deposit):-

5.1 -While submitting commercial bid, the BIDDER shall deposit an amount\_\_\_\_\_\_(as specified in the Bid / Tender document) as Earnest Money/Security Deposit, with NEIGRIHMS, as specified in the Bid /Tender document .

The Earnest Money /Security Deposit shall be valid for a period of (as specified in the Bid /Tenderdocument) or the complete conclusion of the contractual obligations to the complete satisfaction of both the BIDDER and NEIGRI HMS, including warranty period, whichever is later.

In case of the successful BIDDER a clause would also be incorporated in the Article pertaining to Performance Bo nd /Security in the Purchase Contract that the provisions of Sanctions for Violation shall be applicable for forfeitur e of Performance Bond /Security in case of a decision by NEIGRIHMS to forfeit the same without assigning any rea son for imposing sanction for violation of this Pact.

No interest shall be payable by NEIGRIHMS to the BIDDER on Earnest Money / Security Deposit for the period of it s currency.

#### 6. Sanctions for Violations:-

Any breach of the aforesaid provisions by the BIDDER or any one employed by it or acting on its behalfwhether with or without the knowledge of the BIDDER) shall entitle NEIGRIHMS to take all or any one of the following actions, wherever required:

- (i) To immediately call off the pre-contract negotiations without assigning any reason or giving any compensation to the BIDDER. However, the proceedings with the other BIDDER(s) would continue.
- (ii) The Earnest Money Deposit (in pre-contract stage) and / or Security Deposit/Performance Bond (after the cont ract is signed) shall stand forfeited either fully or partially, as decided by NEIGRIHMS and NEIGRIHMS shall not be required to assign any reason therefore.
- (iii) To immediately cancel the contract, if already signed, without giving any compensation to the BIDDER.
- (iv) To recover all sums already paid by NEIGRIHMS, and in case of an Indian BIDDER with interest thereon at 2% hi gher than the prevailing Prime Lending Rate of State Bank of India, while in case of a BIDDER from a country othe r than India with interest thereon at 2% higher than the LIBOR. If any outstanding payment is due to the BIDDER from NEIGRIHMS in connection with any other contract for any other stores, such outstanding payment could als o be utilised to recover the aforesaid sum and interest.
- (v) To encash the advance bank guarantee and performance bond/warranty bond, if furnished by the BIDDER, in o rder to recover the payments, already made by NEIGRIHMS, along with interest.
- (vi) To cancel all or any other Contracts with the BIDDER. The BIDDER shalbe liable to pay compensation for any loss or damage to NEIGRIHMS resulting from such cancellation/rescission and NEIGRIHMS shall be entitled to ded uct the amount so payable from the money(s) due to the BIDDER.
- (vii) To debar the BIDDER from participating in future bidding processes of the Government of India for aminimu m period of five years, which may be further extended at the discretion of NEIGRIHMS.

- (viii) To recover all sums paid in violation of this Pact by BIDDER(s) to any middleman or agent or broker with a view to securing the contract.
- (ix) In cases where irrevocable Letters of Credit have been received in respect of any contract signed by MEIGRIH MS with the BIDDER, the same shall not be opened.
- (x) Forfeiture of Performance Bond in case of a decision by NEIGRIHMS to forfeit the same without assigning ny reason for imposing sanction for violation of this Pact.

NEIGRIHMS will be entitled to take all or any of the actions mentioned at para 6.1 (i) to (x) of this Pacalso on the Commission by the BIDDER or any one employed by it or acting on its behalf (whether with or without the kn owledge of the BIDDER), of an offence as defined in Chapter IX of the Indian Penal Code, 1860, or Prevention of C orruption Act, 1988, or any other statute enacted for prevention of corruption.

The decision of NEIGRIHMS to the effect that a breach of the provisions of this Pact has been committed the BI DDER shall be final and conclusive on the BIDDER. However, the BIDDER can approach the Independent Monitor(s) appointed for the purposes of this Pact.

#### 7. Fall Clause:-

The BIDDER undertakes that it has not supplied/is not supplying similar product/systems or subsystems at a price I ower than that offered in the present bid in respect of any other Ministry / Department of the Government of Indi a or PSU and if it is found at any stage that similar product/systems or sub system was supplied by the BIDDER to any other Ministry/Department of the Government of India or a PSU at a lower price, then that very price, with due allowance for elapsed time, will be applicable to the present case and the difference in the cost would be refunded by the BIDDER to NEIGRIHMS, if the contract has already been concluded.

#### 8. Independent Monitors:

There shall be Independent Monitors (hereinafter referred to as Monitors) appointed by NEIGRIHMS forthis Pact in consultation with the Central Vigilance Commission.

The task of the Monitors shall be to review independently and objectively, whether and to what extent theoreties comply with the obligations under this Pact.

The Monitors shall not be subject to instructions by the representatives of the parties and perform theifunctions neutrally and independently.

Both the parties accept that the Monitors have the right to access all the documents relating to the project/procurement, including minutes of meetings.

8.5 As soon as the Monitor notices, or has reason to believe, a violation of this Pact, he will so inform theuthorit y designated by NEIGRIHMS.

The BIDDER(s) accepts that the Monitor has the right to access without restriction to all Project documentation of N EIGRIHMS including that provided by the BIDDER. The BIDDER will also grant the Monitor, upon his request and d emonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monitor shall be under contractual obligation to treat the information and documents of the BIDDER/Subcontractor(s) with confidentiality.

NEIGRIHMS will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the parties. The partie s will offer to the Monitor the option to participate insuch meetings.

The Monitor will submit a written report to the designated Authority of NEIGRIHMS, within 8 to 10 weeksrom the date of reference or intimation to him by NEIGRIHMS /BIDDER and, should the occasion arise, submit proposals fo r correcting problematic situations.

#### 9. Facilitation of Investigation:-

In case of any allegation of violation of any provisions of this Pact or payment of commission, NEIGRIHMS or its agen cies shall be entitled to examine all the documents including the Books of Accounts of the BIDDER and the BIDDER s hall provide necessary information and documents in English and shall extend all possible help for the purpose of su ch examination.

## 10. Law and Place of Jurisdiction:-

This Pact is subject to Indian Law. The place of performance and jurisdiction is the seat of NEIGRIHMS

## 11. Other Legal Actions:-

The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the extant law in force relating to any civil or criminal proceedings.

#### 12. Validity:

The validity of this Integrity Pact shall be from the date of its signing and extend upto 5 years or the complete ex ecution of the contract to the satisfaction of both NEIGRIHMS and the BIDDER/Seller, including warranty period, w hichever is later. In case BIDDER is unsuccessful, this Integrity Pact shall expire after six months from the date of the signing of the contract.

Should one or several provisions of this Pact turn out to be invalid, the remainder of this pact shallemain valid. In this case, the parties will strive to come to an agreement to their original intentions.
