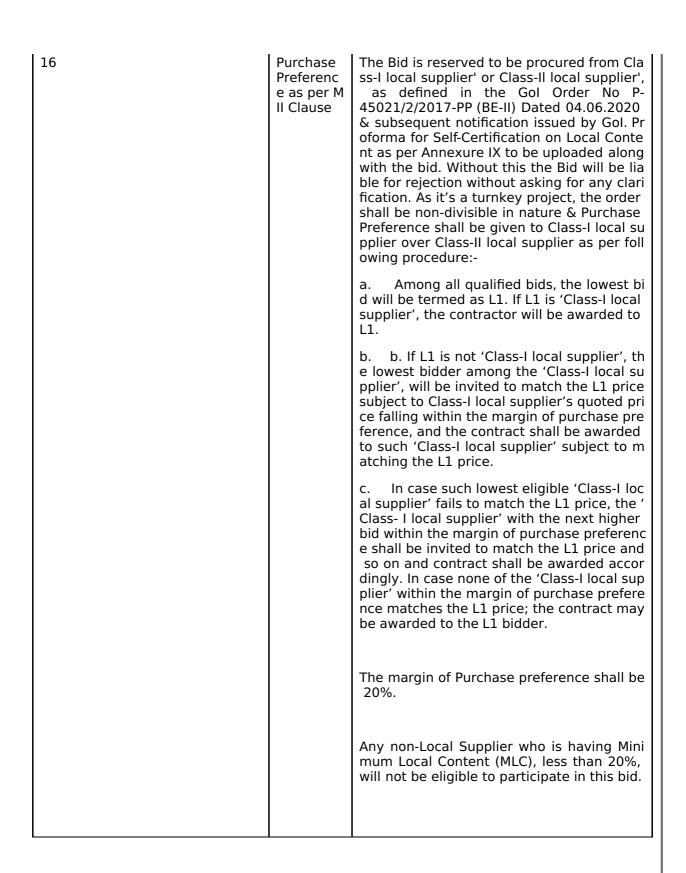

### **Section V- Previous Transgression**

The Bidder shall disclose in its Bid any transgressions occurred in the last 10 years with any other Public Sector Undertaking or Government Department or any other Company, in any country, that may impinge on the Anti-corruption principle.

If the Bidder makes incorrect statement on this subject, it can be disqualified from the tender proc ess or the contract, if already awarded, can be terminated for such reason and further action can be taken in line with NEIGRIHMS' policies.

### Section VI - Equal treatment to all Bidders / Contractors

NEIGRIHMS, Shillong will enter into agreements with identical conditions as this one with all Bidde rs.

NEIGRIHMS, Shillong will disqualify from the tender process any bidder who does not sign this Pac t or violate its provisions.

## **Section VII - Punitive Action against violating Bidders / Contractors**

If NEIGRIHMS, Shillong obtains knowledge of conduct of a Bidder or a Contractor or its subcontract or or of an employee or a representative or an associate of a Bidder or Contractor or his Subcontractor which constitutes corruption, or if NEIGRIHMS, Shillong has substantive suspicion in this regard, NEIGRIHMS, Shillong will inform the Chief Vigilance Officer (CVO).

### (\*)Section VIII - Independent External Monitor/Monitors

NEIGRIHMS, Shillong has appointed a panel of Independent External Monitors (IEMs) for this Pact with the approval of Central Vigilance Commission (CVC), Government of India. The names of the IEMs have been indicated in the Bidding Documents.

The panel of IEMs shall review independently and objectively, whether and to what extent the parties comply with the obligations under this agreement. The panel of IEMs has right of access to all project documentation. The panel of IEMs may examine any complaint received by them and sub mit a report to Chairman-cum-Managing Director, NEIGRIHMS, Shillong giving joint findings, at the earliest. The panel of IEMs may also submit a report directly to the CVO and the CVC, in case of s uspicion of serious irregularities attracting the provisions of the PC Act.

The IEM is not subject to instructions by the representatives of the parties and performs his functions neutrally and independently. He / She reports to the Chairman-cum-Managing Director, NEIGR IHMS, Shillong.

The Bidder(s)/Contractor(s) accepts that the IEM has the right to access without restriction to all d ocumentation of NEIGRIHMS, Shillong related to this contract including that provided by the Contractor/Bidder. The Bidder/Contractor will also grant the IEM, upon his / her request and demonstration of a valid interest, unrestricted and unconditional access to their documentation. The same is a pplicable to Subcontractors. The IEM is under contractual obligation to treat the information and documents of the Bidder(s)/Contractor(s)/Subcontractor(s) with confidentiality.

NEIGRIHMS, Shillong will provide to the IEMs information as sought by him / her which could have an impact on the contractual relations between NEIGRIHMS, Shillong and the Bidder/Contractor related to this contract. The IEMs shall also sign declaration on 'Non- Di

sclosure of Confidential Information' and of 'Absence of Conflict of Interest'. In case of any conflict of interest arising at a later date, the IEM shall inform Chairman-cum- Managing Director, NEIGRI HMS, Shillong and recuse himself/herself from that case.

As soon as the IEM notices, or believes to notice, a violation of this agreement, he / she will so inf orm the Chairman-cum-Managing Director, NEIGRIHMS, Shillong and request the Chairman-cum-Managing Director, NEIGRIHMS, Shillong to discontinue or take corrective action, or to take other relevant action. The IEM can in this regard submit non-binding recommendations. Beyond this, the IEM has no right to demand from the parties that they act in a specific manner, refrain from action or tolerate action. However, the IEM shall give an opportunity to NEIGRIHMS, Shillong and the Bidder/Contractor, as deemed fit, to present its case before making its recommendations to NEIGRIHMS, Shillong.

The IEM will submit a written report to the Chairman-cum-Managing Director, NEIGRIHMS, Shillon g within 8 to 10 weeks from the date of reference or intimation to him by NEIGRIHMS, Shillong, should the occasion arise, submit proposals for correcting problematic situations.

If the IEM has reported to the Chairman-cum-Managing Director, NEIGRIHMS, Shillong a substanti ated suspicion of an offence under PC / IPC Act, and the Chairman-cum- Managing Director, G NEI GRIHMS, Shillong has not, within the reasonable time taken visible action to proceed against such offence or reported it to the CVO, the Monitor may also transmit this information directly to the C VC, Government of India.

While representing any matter in relation to the Integrity pact inter-alia including its transgression to the panel of IEMs, NEIGRIHMS, Shillong and Bidder/Contractor shall not approach the court of law and await the decision of the IEM in the matter.

The word 'IEM' would include both singular and plural.

### **Section IX - Pact Duration**

- **2.** Changes and supplements as well as termination notices need to be made in writing. Side a greements have not been made.
- **3.** If the Contractor is a partnership firm or a consortium or Joint Venture, this agreement must be signed by all partners, consortium members and Joint Venture partners.

SCOPE OF WORK			

### A. Supply, Installation, Commissioning, Integration and Testing:

- 1. Supply, installation, testing, programming, adjusting, and commissioning high quality fast-a cting Video Management Software (VMS) based IP CCTV surveillance system along with all the har dware & VMS software, associated cablings.
- 2. There is total 357 new cameras & 78 existing cameras to be integrated with the new system
- 3. Installation of all the required license software for smooth working of VMS based CCTV syste m.
- 4. Scope also includes installation of VMS Server as per the requirement mentioned in the BoQ out of which 01 Server would be for standby purpose & rest in active mode. If any of the active se rver fails, all the cameras under that particular server should get auto migrated to the active stan dby server & after due rectification the cameras will migrate to its original without any interruption of the recording. Camera to be considered according to the architecture.
- 5. Storage should be configured with RAID-5 to prevent data loss using hot-swappable hard dis k. In case of 1 Hard Disk failure the recording & historical data including schedule, time and motio

n should be available. The solution must have backup for minimum of 60 days from day 1.

- 6. Separate zone of switches to be created. Switches in each zone to be connected to each oth er using 1G OFC in ring topology. All the zones to have a zone master switch which to be connected to distribution switches in ring topology. Switches should be of managed type.
- 7. Video-wall along with matrix switcher at central monitoring room to be installed & configure d.
- 8. There should be total 3 nos. of strategic locations for monitoring facilities locations for viewing cameras.
- 9. 20KVA Centralized Power backup with desired capacity with N+1 to be provided to power d evices in entire hospital and A & B type quarter. Cable from each UPS to be laid to each rack. For other locations, 6KVA UPS at strategic locations.
- 10. List of camera locations will be provided from NEIGRIHMS
- 11. The vendor shall provide training on operation, Maintenance & Troubleshooting aspects of the offered CCTV camera system to NEIGRIHMS, Shillong during commissioning as well as after final handover of the system for uses. Bidder shall consider the same and quote accordingly.
- 12. The bidder shall arrange for all kinds of tools, tackles, testing instruments etc. as required during all operations for completion of work as per the scope of work.
- 13. The bidder shall arrange for all kinds of cable laying, fixing and positioning of networking rac ks with standard dressing, fixing and positioning of cameras, UPS power connectivity at all rack e nds.
- 14. The total length/quantity for supply of the cable will be considered on actual.
- 15. The cables should be laid overhead for outdoor locations using stay wire and GI poles.
- 16. Any other activity / job which may not be specifically mentioned in the scope of work, but required for successful completion of the work shall be part of the bidder's scope without any extra cost to NEIGRIHMS, Shillong.
- 17. It shall be the responsibility of the Bidder that all necessary safety measures and precautions are invariably ensured during execution of work and NEIGRIHMS, Shillong shall not be responsible for any injuries / accidents suffered by contract labour.
- 18. Dedicated / Toll free Telephone No. for service support: Bidder/OEM must have dedicated/Tol I free Telephone for service support.
- 19. Escalation matrix for service support: Bidder and OEM must provide escalation matrix of Tele phone no. for service support.

### B. Cabling and Marking Works:

- 1. For indoor laying of UTP & power cables, MS Conduit to be used.
- 2. For outdoor laying of cables, Poles and stay wires or equivalent to be used.
- 3. Cable dressing inside the control room should be proper with marking and neatly routed so t hat minimum space is required for the cables, and it also looks aesthetically good.
- 4. All the cables shall have proper marking at both ends mentioning the camera/equipment nu mber/name it is connected to at the other end, for easy identification and maintenance.
- 5. 42U Racks to be installed in Server Room for hosting NVRs, Switches, LIUs and other items.
- 6. 12U racks for indoor purpose & hospital area only. 6U indoor racks for colleges, hostel & quarters. 6U outdoor racks for outdoor pole mount purpose only.

- **C. Documents:** The bidder has to give full documentation of the setup which includes the following:
- 1. VMS Programming Manuals.
- 2. User and technical manuals for other bought out items like power systems etc.
- 3. Architectural layout.
- 4. Detailed Connectivity Diagram.
- 5. Positioning and marking of all kinds of CCTV items.
- 6. List of IP addresses of VMS and Cameras.
- 7. User ids and passwords for all kind of active devices.
- 8. Soft copy of all the above documentation shall also be provided in addition to hard copy.
- 9. Warranty Documents.
- 10. Toll free Number for service support.
- 11. Escalation Matrix for service support.

## D. Maintenance and Support Services:

- 1. The maintenance contract period for supplied facility under this package shall be Seven (7) years commencing from Operational Acceptance. Out of which, three (03) years shall be defect lia bility period (DLP)/warranty from the date of taking over/operational acceptance and four (04) ye ars Comprehensive AMC thereafter.
- 2. The warranty shall cover replacement of defective parts, modules and free software upgrad es. In case of delay beyond 7 days for replacement/repair, if any, warranty period will be extende d accordingly.
- 3. The support will be provided on 8 x 6 on working days. For all third-party equipment (Hardw are & Software), Bidder shall have back-to-back support along with supply of spare with appropria te response time from OEM/OEM Authorized representatives. Certificates/Agreement of such support shall be shared with NEIGRIHMS, Shillong along with other documents mentioned above.
- 4. Bidder shall be responsible for coordination with the OEM for all matter related to the equip ment. But the Bidder shall be responsible for meeting the overall response times and availability r equirements specified in the Specification. Bidder shall be responsible for providing all support including but not limited to administration support, reinstallation/ configuration/reconfiguration, tech nical assistance, troubleshooting, answering technical/operational queries, future integration/upgr adation support etc. during the 7 years of maintenance contract period.
- 5. Bidder to have ERP for management of tickets.
- 6. All the spares required for maintenance shall be maintained and provided by the vendor. Sta ndby of equal or higher configuration will be provided by the vendor on breakdown of equipment during DLP (Defect Liability period) / warranty and Comprehensive AMC period till it gets replaced /repaired.
- 7. Take Backup of the system / configurations at regular interval as per policy/requirement.
- 8. MIS report to be submitted on monthly basis to NEIGRIHMS, Shillong.
- 9. Installation of security patches, updates as and when available or as informed by NEIGRIHM S, Shillong. Configuration of supplied software and hardware to manage/close vulnerabilities as a nd when required.
- 10. The maintenance of the System shall be comprehensive and shall comprise of the following category of works which is further elaborated for each of the different subsystems:

- a. Preventive and Breakdown Maintenance Activity (performance monitoring, system backup, p atch management, updates, urgent issues and troubleshooting) as detailed below.
- b. Maintaining a minimum no. of specified spares. It must include 10 nos. of bullet and dome ca meras, four (04) 24 port PoE and 8 port PoE switch. Should give declaration of the same upon bid award on bidder's letterhead.
- c. Integration with new/existing equipment/system as per NEIGRIHMS, Shillong requirement.

### **E.** Special condition of contracts:

- 1. All the technical specifications have to be complied to fully, (any part, compliance or conditi onal compliance will result in rejection of the offer); documentary evidence of these specification from OEM, technical manual and /or database should be submitted to NEIGRIHMS, Shillong.
- 2. All the types of supply of hardware, if some model of the offer equipment is rendered obsole te/ end of life by the successful bidder/ respective OEM higher version of model (of same make) is to be offered by the bidder with the consent of NEIGRIHMS, Shillong without any upward price im plications.
- 3. The bidder is advised to examine site conditions and existing systems where the above-me ntioned works are to be executed before quoting. Any clarification regarding nature work can be d iscussed with the office of In Charge, NEIGRIHMS, Shillong. No deviation/change in tender schedul e and nature of work will be accepted after the tender is opened.
- 4. One high skilled project engineer/supervisor for project management to be provided during execution as per the below qualification:
- a. Graduate + Technical Certified from VMS or Surveillance OEM.
- 5. After commissioning of the project one high skilled, one semi skilled manpower to be provid ed for the period of Seven years. The Salary has to be as per Central Wages Act. With PF & ESI/Me diclaim Benefits. The deputed Engineer has to be certified from the OEM for both Camera, VMS & Passive Equipment's.

# **Disclaimer**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid.
