#### **QUERIES AND REPLY TO REPRESNTATION ON GEM:**

Pointwise explanation for the queries raised.

1. Subject: Representation against Tender Enquiry No.: GEM/2025/B/6871840, Dated: 10-11-2025 for Supply of "Digital Droplet PCR" for North Eastern Indira Gandhi Regional Institute Of Health And Medical Sciences (neigrihms) Reference: Tender Enquiry No: Tender Enquiry No.: GEM/2025/B/6871840, Dated: 10-11-2025 Dear Sir/Ma'am, Gree tings from team QIAGEN I am writing to bring to your kind attention a matter of concern regarding the tender speci fications for above referred tender, which was recently floated by institution. While reviewing the tender documents , we noticed that almost all the specifications seem to favor one particular vendor/Company/ Product, over others. S pecifically, the tender specifications mention "Droplet Digital PCR"/ "Droplet Generator"/ Droplet Reader that favor s one specific vendor/company.

Department of Pathology is at present looking for ddpcr machine which has well established assays for specific can cer like breast cancer ,lung cancer ,colon cancer for diagnosis , for predictive marker study and for follow up of can cer patients.etc which is been used for very long time in well established molecular pathology laboratories of cance r centres and DIAMOnDS centres

2) This requirement appears to be tailored to the capabilities of one specific Vendor/ Company, potentially limiting the participation of other qualified vendors. Digital PCR is next generation quantitative PCR which works on partition of PCR reaction and based on partition method, there are droplet based and physical partition based digital PCR tec hnology. It is not a proprietary technology and either of the technology platform (droplet or physical partition) can be used to meet user requirements. There have been GEM tenders done by renowned institutions like CMR and AllMS Delhi with open specification and same can be used in this case for open tender. We understand that the intent of this open tender process is to ensure fair competition and obtain the best value for the government's money.

However, the current specifications may inadvertently create an unfair advantage for only one specific vendor/company and restrict the participation of other vendors.

Department of Pathology agrees that the digital PCRs can be of multiple partitions with enormous capabilities. How ever we are looking for only a machine which has well established assays for specific cancers like breast cancer lun g cancer colon cancer etc which is been in use for very long time in well established molecular pathology laboratori es of cancer centers and DIAMOnDS centres so that we can validate our assays with these centers who are already using this. Since our purpose is very specific we are not looking for a general use digital PCR at present and opting only for ddPCR.

The startup kit required for demonstration, test run, and final commissioning shall be provided along with the syste m. The OEM shall also provide Installation Qualification (IQ), Operational Qualification (OQ), and Performance Qualification (PQ) documents as and when required by the user department throughout the warranty and CMC period.

### B. Warranty and Maintenance:

- 2. Mandatory 2 PMs / Year with unlimited breakdown calls have to be attended by the Bidder/man ufacturer throughout the warranty & CMC period at site.i.e. NEIGRIHMS, SHILLONG
- 3. Duly signed Mandatory PM reports must be submitted periodically falling which necessary actio n will be initiated as per term& condition of the tender.

### C. Scope of work

- 1. The bidder has to mandatorily quote for all the items /stores mentioned in the Technical Specification & Scope of Work ,failing which bid will be treated as "Non-Responsive" Specification & Scope of Work ,failing which bid will be treated as "Non-Responsive"
- 2. Prices of all accessories (reagents, consumables, controls closed/ open etc) need to be clearly i ndicated as % of the total price in the technical bid Technical Bid ATC1/2 and will be consider f or evaluation as in BOQ or else bid will be treated as "non responsive". The CMC cost offered fr om 3<sup>rd</sup> to the 10<sup>th</sup> year to be indicated in the ATC and shall be quoted in percentage (inclusive of GST) and shall not exceed 5% of the system cost.
- 3. Local content' means the amount of value added in India which shall, unless otherwise prescribed by the Nodal Ministry, be the total value of the item procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all customs duties) as a proportion of the total value, in percent.

Mathematically,

Local content = (Sale price - Value of imported content) \* 100/ Sale price

Where, "Sale price" means price excluding net domestic indirect taxes and "Value of imported content" means price of imported content inclusive of all customs duties

Question2. How to calculate Local Content in bids involving supply of multiple items from single bidder?

Answer: In case of bids requiring supply of multiple items (say "X1", "X2" and "X3") by a single bidder, the local content in the bid shall be

### 13. Service & Support

## 18. Certificates

Material Test Certificate Should Be Sent Along with The Supply. The Material Will Be Checked by Buyer's Lab & the Results of the Lab will be the Sole Criteria for Acceptance of the Item.

### 19. Certificates

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type testertific ate, approval certificates and other certificates as prescribed in the Product Specification given in the bid docum ent.

### 20. Certificates

- All Provisions of Drugs and Cosmetics Act, 1940 and Rules (including Medical Device Rule 2017) made ther
  e under as amended till date will always be applicable. This will include all notifications issued by Central D
  rugs Standard Control Organization (CDSCO), Ministry of Health & Family Welfare (MoHFW) and Departmen
  t of Pharmaceuticals (DOP), Ministry of Chemicals & Fertilizers time to time in this regard.
- 1. The sellers are registered on GeM based on self declaration of valid Medical Device License, product certific ation, test reports etc. However, buyers must check and validate the details at their end for all applicable li censes and certifications e.g., validity and authenticity/genuineness of Medical Device license, product cert ification, manufacturer certification/licenses, test reports etc.
- 2. In case of authorized resellers/distributors, it will be the legal & regulatory liability of the manufacturer to e

### 5. Earnest Money (Security Deposit):-

The BIDDER will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monitor shall be under contractual obligation to treat the information and do cuments of the BIDDER/Subcontractor(s) with confidentiality.

NEIGRIHMS will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the parties. The parties will offer to the Monitor the option to participate insuch meetings.

The Monitor will submit a written report to the designated Authority of NEIGRIHMS, within 8 to 10 weeksrom the date of reference or intimation to him by NEIGRIHMS /BIDDER and, should the occasion arise, submit proposals f or correcting problematic situations.

## 9. Facilitation of Investigation:-

In case of any allegation of violation of any provisions of this Pact or payment of commission, NEIGRIHMS or its age noise shall be entitled to examine all the documents including the Books of Accounts of the BIDDER and the BIDDER shall provide necessary information and documents in English and shall extend all possible help for the purpose of such examination.

# 10. Law and Place of Jurisdiction:-

This Pact is subject to Indian Law. The place of performance and jurisdiction is the seat of NEIGRIHMS

## 11. Other Legal Actions:-

The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the extant law in force relating to any civil or criminal proceedings.

## 12. Validity:

The validity of this Integrity Pact shall be from the date of its signing and extend upto 5 years or the omplete ex ecution of the contract to the satisfaction of both NEIGRIHMS and the BIDDER/Seller, including warranty period, whichever is later. In case BIDDER is unsuccessful, this Integrity Pact shall expire after six months from the date of the signing of the contract.

Should one or several provisions of this Pact turn out to be invalid, the remainder of this pact shalfemain valid. In this case, the parties will strive to come to an agreement to their original intentions.
