GENERAL CONDITIONS OF CONTRACT (GCC):

- 1. Bidders/Tenderers/Manufacturers/Suppliers/Firms/Companies/Contractors would be required to register on the Central Public Procurement Portal (hereafter CPP) at <u>www.eprocure.gov.in</u>, using a valid Digital Signature Certificate (hereafter DSC) and valid email address to be able to participate in the bidding process. On registration with the Portal, they will be provided with a user id and password by the system through which they can submit their bids online. - 2. DSC may be obtained from any authorized agencies registered with the Certifying Authority (CA), through National Informatics Centre (NIC) in India.
- 3. Bidders/Tenderers can download the bid documents from Central Public Procurement Portal website at <u>www.eprocure.gov.in</u>.Bidders/Tenderers are required to submit the bid online only by scanning and uploading all the relevant documents through <u>www.eprocure.gov.in</u> and filling the specified places/blank spaces of "Financial Bid".

Non submission of RTGS/NEFT receipt or no actual transfer of EMD Amount on verification will lead to summarily rejection of bids without any correspondence.
- 9. EMD shall have to be scanned and submitted online along with the submission of original copy of EMD instrument in an envelope to Electrical Section, NEIGRIHMS, Mawdiangdiang, Shillong -793018. The envelope must be earmarked with "Techno-commercial bid and Name/Address/Contact Number/Email of Bidder" and to be submitted/sent by post within the period of tender online submission date and time.
- 10. The Bidder has to download and print this tender document and after signing this tender documents they have to upload the signed tender document online along with all other credentials as part of their acceptance and acknowledgement of all terms and conditions of this tender. Colour Scanned copy of set of signed and stamped tender documents have to be uploaded including scanned copy of EMD. But, EMD in the form of Call deposit or Fixed deposit or Banker's Cheque or Demand draft of any Scheduled Bank shall have to be

- 11. At the time of refund of EMD amount to unsuccessful Bidders (Techno-commercially not qualified/non-responsive), no interest will be paid if the EMD amount is paid by bidder in Demand Draft or Banker's cheque.
- 12. EMD Amount may also be refunded through NEFT/RTGS payment for which Bidders shall have to furnish bank details and Email.
- 13. Correspondences may also be sent through Email to the successful bidder(s) and that has to be valid mode of communication under this tender.
- 14. The Techno-commercial bids will be opened online by the Tender Committee duly constituted for the purpose at the time and date as specified in the tender document.
- 15. - 18. The Financial Bid [i.e. Bill of Quantity (BOQ)] of only Techno-commercially qualified Bidders [i.e. Bidders who are found Techno-commercially responsive with commercial and Techno-commercial competence] will be opened. The Financial Bid will be opened online by a Committee of Members and the result will be displayed on the <u>www.eprocure.gov.in</u> which can be seen by all Techno-commercially qualified Bidders who participated in the tender.
- 19. Tenderers have to quote their rates (inclusive of GST and all other taxes and other levies) both in figure and in words.
- 20. The Bidder shall not sub-let or sub-contract the work to sub-Bidders or to any single sub-Bidder. An undertaking by the Bidder shall have to be submitted to this effect as (On Company's Letter head only) enclosed prescribed format (Format -"A").
- 21. NEIGRIHMS is at liberty to reject or accept any or all offers without assigning any reason thereof. The decision of the office in this regard shall be final and binding. NEIGRIHMS office may also cancel this Notice Inviting Tender fully or partially without assigning any reason thereof and no liability, financial or otherwise, will be borne by the office in this regard.
- 22. The Successful bidder should follow the procedure under various Laws/Acts/rules in force from time to time in connection with disposal of e-waste.
- 23. The e-waste items proposed will be sold"AS IS WHERE IS BASIS" and will be deemed to have been on the understanding that the bidder has satisfied himself/herself/ themselves fully about the conditions,

quality, etc., of the same.

- 24. The inspection of goods at site can be carried out by prospective bidders or their representatives at NEIGRIHMS on all working days before the last date of submission of bids.
- 25. The bidder must be authorised and registered as per E-waste Management Rules, 2016 (as amended from time to time), as a Dismantler/Recycler/Refurbisher/Producer Responsibility Organization of e- Waste with Central Pollution Control Board, Ministry of Environment and Forests, Government of India or with the State Pollution Control Board, etc.
- 26. Self-attested copy of valid Registration Certificate with Central Pollution Control Board, Ministry of Environment and Forests, Government of India or with the State Pollution Control Board only.
- 27. The bidder has to submit online all proofs of work orders placed on the company for disposal of e-waste from Central/State Govt. Departments or from private companies of repute.
- 28. Tenderers are required mandatorily to submit attested copies of Sales Tax/GST registration & PAN card.
- 29. All applicable taxes will be deducted at the source.
- 30. During the execution of the work, the Bidder shall keep the site reasonably free from all unnecessary obstructions and shall store or depose of any of their equipment or surplus materials and clear any wreckage, rubbish or temporary works from the site in consultation with the Engineer-in-charge and/or Sanitary Superintendent of the Institute. Bill/payment for Bidders will be processed only after cleaning of site.
- 31. The Bidder while employing labourers and workmen should ensure that all the statutory labour laws and regulation are adhered to.
- 32. The total number of days for completion is 60 days from the date of issue of letter of Commencement Order.
- 33. The Tenderers are required to furnish an undertaking on a non-judicial stamp paper or temporarily on Company's letter head signed and sealed by authorized signatory that there is no police/vigilance/CBI case pending against them (Format-"B"). If given on Company's letter, then later on the successful bidder have to submit "Format-B" on a non-judicial stamp paper of Rs. 50/- after receipt of work-order from the Institute. Failure to do so will result in cancellation of work-order, forfeiture of EMD, and commencement order will not be given to successful bidder. Furthermore, company will be blacklisted from participating in any other tenders of Institute and same will be intimated to CPP for blacklisting . If at any stage it is detected by NEIGRIHMS or brought into the notice of the Institute that Bidders have concealed information about police/vigilance/CBI case, then Bidders will be disqualified for participation in the future tenders published by NEIGRIHMS and/or Bidders will be blacklisted for any business relationship in future with NEIGRIHMS.
- 34. The Institute reserves the right to accept or reject any or all tenders without assigning any reasons thereof.
- 35. All disputes shall be within the jurisdiction of Courts at Shillong.
- 36. In the event of any question, dispute or difference is arising between the Institute and the bidder relating to any matter arising out of or connected with this tender, the decision of the office shall be final and binding on both the parties.
- 37. Bidder should specially take note of all addendum/corrigendum related to this auction which will be published at the CPPP Web Portal and no separate intimation for the same will be issued by the Office. Any such addendum/corrigendum shall be deemed to be incorporated into this document.
- 38. Bid Validity is for 120 days and may be extended as decided by Competent Authority of NEIGRIHMS
- 39. The Bidder shall be responsible for the safety of all its workmen/employees during the period of execution of the work. The Bidder shall provide all safety materials, gadgets, equipment etc. to all its workmen/employees to ensure their safety during execution of the work. The Institute shall not be held responsible in case of any accidents, mishaps etc. to the party/bidder and its employees.

- 40. During execution of work under this tender, any injury or loss of life of employees/workmen deployed by the bidder due to negligence or any other reason will be sole responsibility of bidder and Institute's officials will be indemnified against such injury or loss of life of employees/workmen deployed by the bidder.
- 41. Any delay in completion of the works beyond the stipulated date due to reasons attributable to the Bidder may eventually lead to cancellation of letter of award for which the Bidder is not entitled to any compensation. The cancellation of letter of award would lead to forfeiture of performance security.
- 42. If the Bidder fails to weigh/remove the e-waste within 60 days (except due to unavoidable and/or unforeseen circumstances and/or due to some bonafide reasons acceptable to NEIGRIHMS) as specified in the work order, the Bidder shall be bound to pay a liquidated damages (hereafter LD) as a sum of 0.5% per week of delay for such default subject to a maximum of 10% (i.e. 20 weeks after scheduled date of completion of work/allowed extension period) of the contract price. LD charges will be deducted from EMD amount.
- 43. No accommodation will be provided by NEIGRIHMS. Bidders have to make arrangement for accommodation for their employees on their own. However, NEIGRIHMS will provide temporary space free of cost for storing of material and tools only required for execution of the work under this tender.
- 44. If at any stage it will be found that any of the bidder(s) [participated in this tender] has/have furnished false/forged documents or adopted any fraudulent methods to get this tender then the said bidder(s) will be disqualified for participation in the future tenders published by NEIGRIHMS or Bidders will be blacklisted for any business relationship in future with NEIGRIHMS.
- 45. No advance payment will be given to the contractor for execution of work in this tender. However, in case of advance payment is asked by the bidder then bank guarantee (of amount equal to work order total cost) shall have to be given by the bidder.
